Low Yu Keat and Mr. Yap Kien Pin, who served as Independent Non-Executive Directors of the Company for a cumulative term of more than nine (9) years, and have recommended that they continue to act as an Independent Non-Executive Directors of the Company based on the following justifications:

- They understand the main drivers of the business and provide a check and balance and
- bring an element of objectivity to the Board of Directors;
 They continue to be scrupulously independent in their thinking and in their effectiveness as constructive challengers of the Chief Executive Officer /Managing Director and Executive Directors: b) Directors: and
- c) They actively participated in Board discussion and provided an independent voice on the Board.

Ordinary Resolution 16: Authority to Directors to Allot and Issue Shares

The Proposed Ordinary Resolution 16, if passed, is a renewal of General Mandate to empower the Directors to issue and allot shares up to an amount not exceeding 10% of the issued share capital of the Company for the time being for such purposes as the Directors consider would be in the best interest of the Company.
