"THAT subject always to the Companies Act, 1965, Articles of Association of the Company and approvals from Bursa Malaysia Securities Berhad and any other governmental/regulatory bodies, where such approval is necessary, authority be and is hereby given to the Directors pursuant to Section 132D of the Companies Act, 1965 to issue not more than ten per centum (10%) of the issued capital of the Company at any time upon any such terms and conditions and for such purposes as the Directors may in their absolute discretion deem fit or in pursuance of offers, agreements or options to be made or granted by the Directors while this approval is in force until the conclusion of the next Annual General Meeting of the Company and that the Directors be and are hereby further authorised to make or grant offers, agreements or options which would or might require shares to be issued after the expiration of the approval hereof."

"THAT subject always to compliance with the Companies Act, 1965 ("Act"), the Articles
of Association of the Company, the Main Market Listing Requirements of Bursa
Malaysia Securities Berhad ("Bursa Securities") or any other regulatory authorities and
all other applicable rules, regulations, guidelines or approval for the time being in force
or as may be amended from time to time, the Directors be and are hereby authorised
to make purchases of ordinary shares of RMIO.50 each in the Company's issued and
paid-up ordinary share capital as may be determined by the Directors from time to time
through Bursa Securities upon such terms and conditions as the Directors may deem
fit, necessary and expedient in the interest of the Company, provided that:

the aggregate number of ordinary shares which may be purchased and/or held by the Company as treasury shares shall not exceed ten per centum (10%) of the total issued and paid-up ordinary share capital of the Company for the time being;

the maximum funds to be allocated by the Company for the purpose purchasing its shares shall not exceed the total retained earnings and shall premium, if any, of the Company at the time of the said purchase(s); and

AND THAT authority be and is hereby given to the Directors and/or anyone of them to complete and do all such acts and things as they may consider necessary or expedient in the best interest of the Company, including executing all such documents as may be required or necessary and with full powers to assent to any modifications, variations and/or amendments as the Directors in their discretion deem fit and expedient to give effect to the aforesaid purchase(s) contemplated and/or authorised by this Ordinary Resolution."

For the purpose of determining who shall be entitled to attend this Annual General Meeting, the Combe requesting Bursa Malaysia Depository Sdn. Bhd. to make available a Record of Depositors as at 1 2017 and only members whose name appear on such Record of Depositors shall be entitled to attend at the meeting.

A member of the Company entitled to attend and vote at the meeting is entitled to appoint not more than two (2) proxies to attend and vote in his stead. Where a member appoints two proxies, the appointment shall be invalid unless the member specifies the proportion of his holdings to be represented by each proxy. A proxy may but need not be a member of the Company and the provision of Section 149(1)(b) of the Act shall not apply.

Where a member of the Company is an exempt authorised nominee as defined under the Securities Industry (Central Depositories) Act, 1991 which holds ordinary shares in the Company for multiple beneficial owners in one (1) securities account ("Omnibus Account"), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each Omnibus Account it holds.

This authorization will empower the Directors of the Company to issue shares notwithstanding that the authorization has ceased to be in force if the shares are issued in pursuance of an offer, agreement or option made or granted by the Directors while the authorization was in force. This authorization will expire at the conclusion of the next Annual General Meeting of the Company.
