Consumers will have the option to choose on the website of MPSB to ship their purchased goods with bpost international to the countries agreed between bpost international and MPSB, and a tool developed by bpost international as a component to the International Trade Lane service offered that calculates and guarantee to the consumer the total landed cost i.e. cost for handling, customs clearance and other services that relate to the importation of the goods in the country of clearance, the possible customes duties, possible Value Added Tax and Government Service Tax, and other possible taxes upon importation that are at the expense of the consumer.
