- Ordinary Resolutions 7, 8 and 9 Retention of Dato' Siew Mun Chuang, Dato' Ahmad Bakri bin Shabdin and Dato' Maarof bin H.A. Rahman as Independent Non-Executive Directors Pursuant to the Malaysian Code on Corporate Governance 2012, the tenure of an independent Director should not ex
 - cumulative term of nine years unless an approval is sought from the Company's shareholders at the Annual General Meeting to retain the said director as an independent director. The Nomination Committee has assessed the independence of Dato' Siew Mun Chuang, Dato' Ahmad Bakri bin Shabdin and Dato' Maarof bin H.A. Rahman who each has served as an Independent Non-Executive Director of the Company for a cumulative term of more than nine years, and the Board has recommended to retain them as Independent Non-Executive Directors of the Company based on the following justifications:
 - each of them fulfills the criteria of an Independent Director pursuant to the Main Market Listing Requirements of Bursa Malaysia Securities Berhad and is able to bring independent and objective judgment to the Board; each of them is familiar with the Company's business operations as he has been with the Company for more than 9 (i) (ii)
