NOTICE OF EXTRAORDINARY GENERAL MEETING

NOTICE IS HEREBY GIVEN THAT an Extraordinary General Meeting of Tiong Nam Logistics Holdings Berhad ("Tiong Nam" or the "Company") will be held at Lot 30462, Jalan Kempas Baru, 81200 Johor Bahru, Johor Darul Takzim on Tuesday, 17 December 2013 at 11.00 a.m. for the purpose of considering and, if thought fit, passing with or without modifications or additions the following ordinary resolution:

PROPOSED ACQUISITION BY TIONG NAM LOGISTICS SOLUTIONS SDN BHD ("TNLS"), A WHOLLY-OWNED SUBSIDIARY OF TIONG NAM LOGISTICS HOLDINGS BERHAD ("TIONG NAM") OF TWENTY (20) PARCELS OF LAND (THE PARTICULARS OF WHICH ARE TABULATED BELOW) ("LOGISTIC ASSETS") FROM ABS LOGISTICS BERHAD ("ALB") FOR A TOTAL PURCHASE CONSIDERATION OF RM176.3 MILLION TO BE SATISFIED BY RM125.0 MILLION IN CASH WITH THE BALANCE OF RM51.3 MILLION AS AMOUNT OWING BY TNLS TO ALB, PURSUANT TO THE EXERCISE OF THE CALL OPTION GRANTED TO TNLS BY ALB UNDER THE CALL OPTION AGREEMENT DATED 26 JANUARY 2007

THAT subject to the approvals being obtained from the relevant authorities and/or parties, where required, approval be and is bereby given for TNLS to undertake the proposed acquisition of the following properties together with all rights, title and interest held by ALB therein, for a total consideration of RM176.3 million to be satisfied by RM125.0 million in cash with the balance of RM51.3 million as amount owing by TNLS to ALB, pursuant to the issuance of an exercise notice dated 30 July 2013 under the call option agreement dated 26 January 2007 between TNLS and ALB and upon the terms and conditions of the conditional sale and purchase agreement dated 30 July 2013 entered into between TNLS and ALB (including any amendments and/or modifications thereto) ("Proposed Acquisition"):
