THAT the authorised share capital of the Company be and is hereby increased fron RM50,000,000/- divided into 500,000,000 ordinary shares of RM0.10 each to RM100,000,000/ divided into 1,000,000,000 ordinary shares of RM0.10 each by the creation of 500,000,000 new ordinary shares of RM0.10 each had such new ordinary shares when issued shall rank pari passuin all respects with the existing ordinary shares in the capital of the Company.*

The capital of the Company is Ringgit Malaysia Fifty Million only (RM50,000,000/-) divided into 500,000,000 shares of RM0.10 each with power for the Company to increase or reduce the said capital, and to vary or abrogate the rights attached to any class of shares in the Company and to issue any part of its capital, original or increased, with or without any preference, priority or special privilege, or subject to any postponement or rights or to any conditions, or restrictions; and so that, unless the conditions of issue shall otherwise expressly declare, every issue of shares whether declared to be preference or otherwise, shall be subject to the powers hereinbefore contained.

AND THAT the Directors and Secretaries of the Company be and are hereby at all steps as are necessary and expedient in order to implement, finalise and give Proposed Amendments of the Company's Memorandum of Association."

The authorised capital of the Company is Ringgit Malaysia One Hundred Million (RM100,000,000/-) divided into One Billion (1,000,000,000) ordinary shares of RM0.10 each. The shares in the original or any increased capital may be divided into several classes and there may be attached thereto respectively any preferential, deferred or other special rights, privileges, conditions or restrictions as to dividends, capital, voting or otherwise.

The purpose to seek the General Mandate is to enable the Directors of the Company to issue and allot shares at any time to such persons in their absolute discretion without convening a general meeting provided that the aggregate number of the shares issued does not exceed 10% of the issued and paid-up share capital of the Company for the time being. The General Mandate, unless revoked or varied by the Company in a general meeting, will expire at the conclusion of the next Annual General Meeting of the Company.

In respect of deposited securities, only members whose names appear in the Record of Depositors on 18 June 20 ("General Meeting Record of Depositories") shall be eligible to attend the Meeting.

A proxy may but need not be a member of the Company and the provisions of Sections 149(1)(a) and (b) of the Companies Act, 1965 shall not apply to the Company. There shall be no restriction as to the qualification of the proxy. A proxy appointed to attend and vote at the Meeting shall have the same rights as the member to speak at the Meeting.

Where a member of the Company is an exempt authorised nominee as defined under the Securities Industry (Central Depositories) Act 1991 ("SICDA") which holds ordinary shares in the Company for multiple beneficial owners in one securities account ("omnibus account"), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each omnibus account it holds. Where a member is an authorised nominee as defined under SICDA, it may appoint at least one (1) proxy in respect of each Securities Account it holds with ordinary shares of the Company standing to the credit of the said Securities Account.

The instrument appointing a proxy shall be in writing under the hand of the appointer or of his attorney duly auth in writing or, if the appointer is a corporation, either under Seal or under the hand of an officer or attorne authorised.

A member of the Company entitled to attend and vote at the Meeting is entitled to approxies to attend and vote in his stead. Where a member appoints more than one (1) pr Meeting, such appointment shall be invalid unless he specifies the proportions of his sha by each proxy.
