 The authority conferred by this resolution will be effective immediately upon the passing of this Ordinary Resolution and will expire at conclusion of the next Annual General Meeting of the Company, unless renewed or earlier revoked or varied by ordinary resolution of shareholders of the Company in a general meeting or the expiration of the period within which the next Annual General Meeting after date is required by law to be held, whichever occurs first, but not so as to prejudice the completion of purchase(s) by the Company beff the aforesaid expiry date and, in any event, in accordance with the provisions of the Main Market Listing Requirements of Bursa Securit or any other relevant authorities.

- A member entitled to attend, speak and vote at the meeting is entitled to appoint at least one (1) proxy to attend, speak and vote in his stead and where a member appoints two (2) or more proxies, he shall specific the proportion of his shareholdings to be represented by each proxy. A proxy need not be a member of the Company and a member may appoint any person to be his proxy without limitation and the provision of Section 149(1)(b) of the Companies, Act, 1965 shall not apply to the Company; and understand the proxy without limitation and the provision of Section 149(1)(b) of the Companies, Act, 1965 shall not apply to the Company is an authorised nominee as defined under the Securities Industry (Central Depositories) Act 1991, it may appoint a least one (1) proxy in respect of each securities account it holds with ordinary shares of the Company standing to the credit of the said securities account. Proposed Renewal of Share Buy-Back Authority

Resolution 11, if passed, will empower the Company to purchase and/or hold the Company's shares up to ten percent (10%) of the issued and paid-up share capital of the Company by utilising the funds allocated which shall not exceed the total retained profits and/or share premium account of the Company. This authority, unless renewed, revoked or varied at a general meeting, will expire at the conclusion of the next Annual General Meeting of the Company. Further information on the Proposed Renewal of Share Buy-Back Authority is set out in the Share Buy-Back Statement dated 24 November 2014, which is dispatched together with the Company's Annual Report 2014.

Retention of Independent Non-Executive Directors

Resolutions 12, 13 and 14, if passed, will allow the Independent Non-Executive Directors to be retained and continue acting as independent directors the requirements of Paragraph 3.04 of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad and in line with the Recommend of the Malaysian Code on Corporate Governance 2012. The justifications and recommendations for the retention are set out in page 41 of the State Corporate Governance in the Company's Annual Report 2014.
