 - the transactions are carried out in the ordinary course of business, on arms length basis, on normal commercial terms which are not more favourable to the related parties than those generally available to the public and are not detrimental to the minority shareholders; and
 - ii) disclosure of the aggregate value of transactions pursuant to the Proposed Shareholders' Mandate conducted during a financial year will be made in the annual report for the said financial year.

That such approval shall continue to be in force until the earlier of:

- the conclusion of the next Annual General Meeting of the Company at which time it will lapse unless the authority is renewed by a resolution passed at the next Annual General Meeting; or
- ii) the expiration of the period within which the next Annual General Meeting is to be held pursuant to Section 143(1) of the Companies Act 1965 ("the Act") (but shall not extend to such extension as may be allowed pursuant to Section 143(2) of the Act); or
- iii) is revoked or varied by resolution passed by shareholders in a general meeting before the next Annual General Meeting.

And that the Directors of the Company be authorized to complete and do all such acts and things (including executing all such documents as may be required) as they may consider expedient or necessary to give effect to the Proposed Shareholders' Mandate."

- 1. A member of the Company entitled to attend and vote at the meeting is entitled to appoint a proxy or proxies to attend and vote in his/her stead. A proxy may but need not be a member of the Company and the provisions of Section 149(1)(b) of the Companies Act 1965 shall not apply to the Company.
- 2. Where a member appoints two or more proxies, the appointment shall be invalid unless he/she specifies the proportion of his/her holdings to be represented by each proxy.

- 3. Where a Member of the Company is an authorized nominee as defined under the Securities Industry (Central Depositories) Act 1991, it may appoint at least one (1) proxy but not more than two (2) proxies in respect of each securities account it holds which is credited with ordinary shares of the Company.
- 4. Where a Member of the Company is an exempt authorized nominee as defined under the Securities Industry (Central Depositories) Act 1991 which holds ordinary shares in the Company for multiple beneficial owners in one securities account ("Omnibus Account"), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each Omnibus Account it holds.
- 5. The instrument appointing a proxy shall be in writing under the hand of the appointor or his/her attorney duly authorised in writing or, if the appointor is a corporation, either under its common seal or under the hand of an officer or attorney duly authorised.

Continuation in office as Independent Non-Executive Director pursuant to Recommendation 3.3 of the Malaysian Code on Corporate Governance 2012

In line with the Malaysian Code on Corporate Governance 2012, the Nomination Committee has assessed the independence of Datuk Wira Haji Jaafar Bin Haji Lajis who served as Independent Non-Executive Directors of the Company for a cumulative term of more than nine years, and have recommended that he continues to act as Independent Non-Executive Directors based on the following justifications:

- (a) He understands the main drivers of the business and provide a check and balance and bring an element of objectivity to the Board of Directors.
- (b) He continues to be scrupulously independent in his thinking and in his effectiveness as constructive challenger of the Managing Director and Executive Directors
- (c) He actively participated in board discussion and provided an independent voice on the Board.

Resolution 8

Authority to Issue Shares pursuant to Section 132D of the Companies Act, 1965

The proposed Resolution 8 which is an Ordinary Resolution, if passed, will grant a renewed general mandate (Renewed Mandate) and give the Directors of the Company authority to issue shares of the Company up to an amount not exceeding in total 10% of the issued share capital of the Company for such purposes as the Directors consider would be in the interest of the Company. This would avoid any delay and cost involved in convening a general meeting to specifically approve such an issue of shares. This authority, unless revoked or varied at a general meeting, will expire at the next Annual General Meeting of the Company.

The Renewed Mandate will provide flexibility to the Company for allotment of shares for any possible fund raising activities, including but not limited to further placing of shares, for the purpose of funding future investment(s), acquisition(s) and/or working capital.

On 16 January 2015, the Company had issued 323,769,580 new ordinary shares of RM0.10 each in the capital of the Company at an issue price of RM0.10 per rights share by way of Rights Issue of Shares with Warrants pursuant to the mandate granted to the Directors at the Eleventh Annual General Meeting held on 24 September 2014 and which will lapse at the conclusion of the Twelfth Annual General Meeting to be held on 28 September 2015.

The proceeds of RM32,376,958 raised from the Rights Issue of Shares with Warrants was fully utilised as follows:
