The Board of Directors is of the opinion that both Tan Sri Abdul Aziz bin Mohd Yassin and Mr. Lim Swee Chong have met the independence guidelines as set out in Chapter 1 of Bursa Malaysia Securities Berhad's Main Market Listing Requirements. The length of their service does not impair with Tan Sri Abdul Aziz bin Mohd Yassin's and Mr. Lim Swee Chong's ability and exercise of independent judgment as Independent Directors. Therefore, the Board of Directors has recommended that the approval of the shareholders be sought to continue retaining Tan Sri Abdul Aziz bin Mohd Yassin and Mr. Lim Swee Chong as the Independent Non-Executive Directors of the Company.
