# NOTES ON APPOINTMENT OF PROXY-

- A member of the Company entitled to attend and vote at the Meeting is entitled to appoint not more than two (2) proxies to attend and
  vote in his stead. A proxy may but need not be a member and / or a qualified legal practitioner, an approved company auditor or a person
  approved by the Redistrar of Companies.
- Where a member duly executes the form of proxy but does not name any proxy, such member shall be deemed to have appointed the Chairman of the meeting as his/finelier proxy, provided always that the rest of the proxy form, other than the particulars of the proxy have been duly completed by the member.
- Where a member appoints more than one proxy, the appointment shall be invalid unless he specifies the proportion of his holding to be represented by each proxy.
- Where a member of the Company is an exempt authorised nominee defined under the Central Depositories Act which is exempted from compliance with the provision of subsection 25A (1) of the Central Depositories Act which is exempted from compliance with the provision of subsection 25A (1) of the Central Depositories Act which holds ordinary shares in the Company for
