5.4.4 Upon completion of the purchases(s) of the shares by the Company, the shares shall be dealt with in the following manner:

a) to cancel the shares so purchased; or

b) to retain the shares so purchased; or

a) to cancel the shares so purchased; or

A member of the Company who is entitled to attend and vote at a meeting of the Company, may appoint not more than two (2) proxies to attend and vote instead of the member at the meeting

A member of the Company who is entitled to attend and vote at a meeting of the Company, may appoint not more than two (2) proxies to attend and vote instead of the member at the member.
