The proposed Ordinary Resolution No. 7, if passed, will allow the independent director to be retained and continue acting as independent director to fulfill the requirement of Paragraph 1.01 of the ACE Market Listing Requirements and in line with the recommendation Nos. 3.2 and 3.3 of the Malaysian Code on Corporate Governance 2012. The full details of the justification and recommendations for the retention is set out in the Statement of Corporate Governance in the Annual Report 2018 on page 18.

The Company had, during its Twelfith Annual General Meeting ("AGM") held on 24 May 2017, obtained its shareholders' approval for the general mandate for issuance of shares pursuant to Sections 75 and 76 of the Companies Act, 2016 ("the Act"). The previous mandate was not utilised and accordingly no proceeds were raised.

The Ordinary Resolution 8 proposed under item 8 of the Agenda is a renewal of the general mandate for issuance of shares by the Company under Section 76 of the Companies Act, 2016. The mandate, if passed, will provide flexibility for the Company and empower the Directors to allot and issue new shares speedily in the Company up to an amount not exceeding in total 10% of the issued share capital of the Company for purposes of funding investment(s), working capital and general corporate expenses as deemed necessary. This would eliminate any delay arising from and cost involved in convening a general meeting to obtain approval of the shareholders for such issuance of shares. This authority, unless revoked or varied by the Company at a general meeting, will expire at the next Annual General Meeting.
