Explanatory Notes on Special Business:

Resolution 7

The Ordinary Resolution 7 is proposed to seek a renewal of general mandate for authority to issue shares pursuant to Sections 75 and 76 of the Act. If the resolution is passed, it will give the Directors of the Company from the date of the above meeting, authority to issue and allot shares in the Company up to an amount not exceeding in total 10% of the issued share capital of the Company, for such purposes as the Directors would consider in the best interest of the Company. The approval is sought to avoid any delay and cost involved in convening a general meeting for such issuance of shares. This authority will, unless revoked or varied by the Company in a general meeting, expire at the next AGM of the Company.

The general mandate for issue of shares will provide flexibility to the Company for any possible fund raising activities, includir to further placement of shares for the purpose of repayment of bank borrowings, funding future investment and working cap uding but not limited

The Company had undertaken a Bonus Issue of up to 79,840,322 new ordinary shares in the Company ("Bonus Issue") to be credited as fully paid-up on the basis of 1 Bonus Share for every 8 existing shares of the Company ("Bonus Issue"). The Bonus Issue has been completed following the listing of and quotation for 66,454,852 new Bonus Share (including 184,762 treasury shares) pursuant to the Bonus Issue and 12,910,919 additional warrants arising from the adjustment as a result of the Bonus Issue on the Main Market of Bursa Securities on 17 December 2018. The Ordinary Resolution 8, if passed will enable the Company and its subsidiaries to enter into recurrent related party transactions of a revenue or trading nature pursuant to Paragraph 10.09 of the Main Market Listing Requirements of Bursa Securities.

The Nomination Committee has assessed the independence of Raja Tan Sri Dato' Seri Aman bin Raja Haji Ahmad and Datuk (Prof.) A. Rahman @ Omar bin Abdullah, who have served as Independent Non-Executive Directors of the Company for a cumulative term of more than 9 years and the Board has recommended them to continue to act as Independent Non-Executive Directors of the Company based on the following justifications:

- They had fulfilled the criteria under the definition of Independent Directors as stated in the Main Market Listing Requirements of Bursa Securities, and hence, they would be able to provide an element of objectivity, independent judgement and balance to the Board; (i)
- Their length of services on the Board of more than 9 years does not in any way interfere with their exercise of objective judgement or their ability to act in the best interests of the Company and Group. In fact, both of them, having been with the Company for more than 9 years, are familiar with the Group's business operations and have devoted sufficient time and commitment to their role and responsibilities as Independent Directors for informed and balance decision making; and (ii)
- They have exercised due care during their tenures as Independent Directors of the Company and have discharged their duties with reasonable skill and competence, bringing independent judgement and depth into the Board's decision making in the interest of the Company and its shareholders. (iii)
