The audited financial statements are laid in accordance with Section 340(1)(a) of the Companies Act, 2016 for discussion only under Agenda 1. They do not require shareholders' approval and hence, this Agenda item will not be put for voting.

Ordinary Resolutions 5 and 6 — Directors' Fees and Benefits
In accordance with Section 230(1) of the Companies Act, 2016, the fees of the Directors and any benefits payable to the directors of a
public company or a listed company and its subsidiaries, shall be approved at a general meeting.

The Company pays Directors' fees and benefits and the subsidiary companies, namely APM Springs Sdn. Bhd. and Auto Parts
Manufacturers Co. Sdn. Bhd. pay Directors' fees to the Independent Non-Executive Directors. The Executive Directors do not receive
any fees and benefits as Directors but they are remunerated with salary, benefits and other emoluments by virtue of their contract of
service or employment which do not behalves a propriate agreement of the Nandal Company agreement.

The Board recommends that shareholders approve a maximum aggregate amount of RM490,000 for the payment of Directors' fees to the Independent Non-Executive Directors of the Company during the course of the period from 1 June 2020 until the next Annual General Meeting, and an aggregate amount of RM26,000 for the payment of Directors' fees to the Independent Non-Executive Directors of APM Springs 50n. Bhd. and Auto Parts Manufacturers Co. 5dn. Bhd. frespectively during the course of the period from 1 June 2020 until the next Annual General Meeting of the Company.

The Board also recommends that shareholders approve a maximum aggregate amount of RM130,000 for the payment of benefits which mainly consist of meeting allowances (i.e. as Chairman of meeting of RM1,500 per meeting) and as Board/Board Committee member of RM1,200 per meeting) to the Independent Non-Executive Directors of the Company during the course of the period from 1 June 2020 until the next Annual General Meeting of the Company.
