 - Read and agree to the Terms & Conditions and confirm the Declaration.
 - Select "Register for Physical Attendance at Meeting Venue".
 - Review your registration and proceed to register.
 - System will send an e-mail to notify that your registration for Physical Attendance at

Meeting Venue is received and will be verified.
