1) IMPORTANT NOTICE:-

The 6th Annual General Meeting (“AGM”) of the Company will be conducted fully virtual through live streaming and online remote voting using the Remote Participation and Voting Facility (“RPV”). This is in line with the Guidance Notes and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020, and its subsequent revisions including any amendments that may be made from time to time.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be present at the main venue of the AGM. NO SHAREHOLDERS/PROXIES/CORPORATE REPRESENTATIVES from the public shall be physically present at the Broadcast Venue on the day of the AGM.

Shareholders of the Company are to participate, speak (in the form of real time submission of typed texts) and vote remotely at the AGM using RPV provided by the Company’s Share Registrar via its website at www.sunwaymanagement.com.my. Please follow the Procedures for RPV provided in the Administrative Details for the AGM.

- 2) A shareholder of the Company who is entitled to participate, speak and vote at the AGM via RPV, may appoint more than 1 proxy to attend and vote instead of the shareholder at the AGM. A proxy need not be a shareholder.
- 3) Shareholders may use the RPV platform to submit questions in real time during the AGM. Shareholders may also submit questions to the Board prior to the AGM by emailing to irsuncongroup@sunway.com.my or via Q&A box in www.sunwaymanagement.com.my no later than 3.00 p.m. on Tuesday, 4 August 2020 i.e. 24 hours before the AGM.
- 4) Where a shareholder is an authorised nominee as defined under the Securities Industry (Central Depositories) Act 1991, it may appoint at least 1 proxy in respect of each securities account it holds in ordinary shares of the Company standing to the credit of the said securities account.
- 5) Where a shareholder is an exempt authorised nominee which holds ordinary shares in the Company for multiple beneficial owners in 1 securities account (“omnibus account”), there is no limit to the number of proxies which the exempt authorised nominee may appoint in respect of each omnibus account it holds.
- 6) Where a shareholder appoints more than 1 proxy, the appointment shall be invalid unless he specifies the proportions of his/her shareholdings to be represented by each proxy. A proxy appointed to participate, speak and vote at the AGM shall have the same rights as the shareholder to speak and vote at the AGM.
- 7) If a shareholder has appointed a proxy to attend a meeting and subsequently he attends such meeting via the RPV, the appointment of such proxy shall be null and void, and his proxy shall not be entitled to attend the AGM.
- 8) The instrument appointing a proxy shall be in writing under the hand of the appointer or of his attorney duly authorised in writing, or if such appointer is a corporation, either under its common seal or the hand of its officer or attorney duly authorised.
- 9) In the case where the shareholder is a corporation and the proxy form is delivered by fax or electronic mail, the original proxy form shall also be deposited at the Registered Office at Level 16, Menara Sunway, Jalan Lagoon Timur, Bandar Sunway, 47500 Subang Jaya, Selangor Darul Ehsan, Malaysia either by hand or post not less than 24 hours before the time appointed for holding the AGM or any adjournment thereof.
- 10) The instrument appointing a proxy must be deposited at the Registered Office of the Company at Level 16, Menara Sunway, Jalan Lagoon Timur, Bandar Sunway, 47500 Subang Jaya, Selangor Darul Ehsan, Malaysia not less than 24 hours before the time appointed for holding the meeting or any adjournment thereof, either by hand, post, electronic mail to sunwaymanagement@sunway.com.my or fax to (603) 5639 9507. In the case where the member is a corporation and the proxy form is delivered by fax or electronic mail, the original proxy form shall also be deposited at the Registered Office, either by hand or post not less than 24 hours before the time appointed for holding the meeting or any adjournment thereof.
- 11) In respect of deposited securities, only shareholders whose names appear in the Record of Depositors on 29 July 2020 shall be entitled to attend, speak and vote at the general meeting.

Ordinary Business

1. To receive the Audited Financial Statements for the financial year ended 31 December 2019 together with the Directors' and Auditors' Reports thereon

The Audited Financial Statements are for discussion only as they do not require shareholders' approval pursuant to the provision of Section 340(1) of the Companies Act 2016 ("Act"). As such, this agenda will not be put for voting.

2. Ordinary Resolution 1 - To approve the payment of fees to Non-Executive Directors amounting to RM695,000 for the financial year ended 31 December 2019

The Company has adopted the following fees structure for its Non-Executive Directors ("NEDs"):-

Board/Audit Committee	Chairman (RM/annum)	Member (RM/annum)
Board	180,000	100,000
Audit Committee	6,000	3,000

The payment of the Directors' fees for the financial year ended 31 December 2019 will only be made if the Proposed Resolution 1 has been approved at the 6th Annual General Meeting ("AGM") pursuant to Clause 95 of the Constitution of the Company and Section 230 of the Act.

3. Ordinary Resolution 2 - To approve the payment of benefits payable to Non-Executive Directors from 5 August 2020 until the conclusion of the next AGM of the Company to be held in 2021

Pursuant to Section 230 of the Companies Act 2016, any fees and benefits payable to the NEDs of a listed company and its subsidiaries shall be approved at a general meeting. The benefits payable to the NEDs of the Company comprises the following:

- (i) Meeting allowance of RM500 per meeting for attending the Board or Board Committee Meetings;
- (ii) Other emolument, including but not limited to the meeting allowance or construction site visit allowance of RM1,000 per meeting/visit for discharging the duty as Chairman of the High Level ESH (Environmental, Safety and Health) Council of the Company.

4. Ordinary Resolutions 3 and 4 - To re-elect Dato' Dr Ir Johari Bin Basri and Dato' Chew Chee Kin as Directors of the Company

Clause 106(1) of the Company's Constitution provides that one-third or the number nearest to one-third of the Directors of the Company (including Managing Director) for the time being shall retire by rotation at each AGM of the Company. Each Director shall retire from office once at least in each three years but shall be eligible for re-election.

Dato' Dr Ir Johari Bin Basri and Dato' Chew Chee Kin, who retire by rotation pursuant to Clause 106(1) of the Company's Constitution, being eligible, have offered themselves for re-election at the 6th AGM.

The Nomination and Remuneration Committee ("NRC") had assessed the performance of the retiring Directors and recommended them for re-election as Directors of the Company due to their vast experience and contribution to the Company. Their profiles are enclosed in pages 54 to 57 of the Company's Annual Report 2019. The Board has endorsed the NRC's recommendation subject to the shareholders' approval at this AGM.

All Directors standing for re-election have abstained from deliberations and decisions on their own eligibility to stand for re-election at the relevant NRC and Board Meeting and will continue to abstain from deliberations and decisions on their own eligibility to stand for re-election at this AGM.

Special Business

5. Ordinary Resolution 6 - Authority to Issue Shares pursuant to Sections 75 and 76 of the Companies Act 2016

The Company is always on the look out for investment opportunities to enhance the earnings potential of the Company. If any investment opportunities involve the issue of new shares, the Directors, under present circumstances, would have to convene a general meeting to approve the issue of new shares even though the number involved may be less than 10% of the total number of issued shares of the Company.

In order to avoid any delay and costs involved in convening a general meeting to approve such issue of shares, it is thus considered appropriate that the Directors be empowered to issue new shares in the Company, up to an amount not exceeding in total 10% of the total number of issued shares of the Company at any time, for such purpose. This authority, unless revoked or varied at a general meeting, will expire at the next AGM of the Company.

The renewal of this mandate will provide flexibility to the Company for any potential fund raising activities, including but not limited to placement of shares, for purpose of funding future investments, working capital and/or any acquisition.

At this juncture, there is no decision to issue new shares. Should there be a decision to issue new shares after the authorisation is sought, the Company will make an announcement of the actual purpose and utilisation of proceeds arising from such issuance of shares.

The Company did not issue any new shares under the general mandate which was approved at its 5th AGM held on 19 June 2019.

6. Ordinary Resolution 7 - Proposed Renewal of Shareholders' Mandate for Recurrent Related Party Transactions of a Revenue or Trading Nature
