## NOTICE OF EXTRAORDINARY GENERAL MEETING

NOTICE IS HEREBY GIVEN an extraordinary general meeting of T7 Global Berhad ("T7" or the "Company") ("EGM"), which will be conducted fully virtual at the Broadcast Venue at Level 16, KL Trillion Corporate Tower, Block C, 338 Jalan Tun Razak, 50400 Kuala Lumpur, Wilayah Persekutuan via remote participation and voting facilities on Tuesday, 17 November 2020 at 11:00 a.m. or immediately following the conclusion or the adjournment (as the case may be) of another EGM, which will be held virtually at the same venue and on the same day at 10:00 a.m., whichever is later, for the purpose of considering and if thought fit, passing with or without modifications, the following resolution:-

#### ORDINARY RESOLUTION

PROPOSED ACQUISITION BY T7 GASTEC SDN BHD, A WHOLLY-OWNED SUBSIDIARY OF T7, OF 490,000 ORDINARY SHARES OF T7 WENMAX SDN. BHD. ("T7 WENMAX"), REPRESENTING 49.0% EQUITY INTEREST IN T7 WENMAX, FOR A PURCHASE CONSIDERATION OF RM39,200,000 TO BE SATISFIED ENTIRELY VIA CASH ("PROPOSED ACQUISITION")

"THAT, subject to the approvals of all relevant authorities in respect of the Proposed Acquisition, and/ or parties being obtained, approval be and is hereby given to the Company to acquire 490,000 ordinary shares in T7 Wenmax, representing 49.0% equity interest in T7 Wenmax from Megaxus Resources Sdn Bhd (the "Vendor") for a total purchase consideration of RM39,200,000 to be satisfied entirely via cash, in accordance with the terms and conditions of the conditional share sale and purchase agreement dated 22 September 2020 entered into between T7 Gastec and the Vendor.

AND THAT the Board of Directors of the Company ("Board") be and is hereby authorised to sign and execute all documents, do all things and acts as may be required to give effect to the Proposed Acquisition with full power to assent to any conditions, variations, modifications and/ or amendments in any manner as may be required or permitted by any relevant authorities and to deal with all matters relating thereto and to take all such steps and do all acts and things in any manner as they may deem necessary or expedient to implement, finalise and give full effect to the Proposed Acquisition."

- The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020 (including any amendment that may be made from time to time) which require the Chairperson of the meeting to be present at the main venue of the meeting.
