#### REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Members are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 16th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <a href="https://tiih.online">https://tiih.online</a>. Please refer to Procedure for RPV.

Only members whose names appear in the **Record of Depositors as at 5 November 2020** shall be entitled to participate and vote remotely at the 16th AGM or appoint proxy to participate and vote on his/her behalf.

As the 16th AGM is a fully virtual AGM, members who are unable to participate in this AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

#### PROCEDURES FOR RPV

#### Notes to users of the RPV facilities:

- 1. Should your registration for RPV be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.
- 3. Corporate members who wish to appoint corporate representatives are required to deposit their **ORIGINAL** certificate of appointment of corporate representative at Tricor's office as provided above not later than **Tuesday**, **10 November 2020 at 10.00 a.m.** to participate via RPV in the 16th AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney at Tricor's office as provided above not later than **Tuesday**, **10 November 2020 at 10.00 a.m.** to participate via RPV in the 16th AGM.

A member who has appointed a proxy/authorised representative/attorney to participate in the 16th AGM via RPV must request his/her proxy/authorised representative/attorney to register himself/herself for RPV at TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>. #### **POLL VOTING**

The voting at the 16th AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from 10.00 a.m. on **Thursday, 12 November 2020** but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to item (e) of the above Procedures for RPV for guidance on how to vote remotely from TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

Upon completion of the voting session for the 16th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
