**NOTIFICATION TO SHAREHOLDERS OF A
FULLY VIRTUAL MEETING**

Dear Shareholders,

We refer to our announcement dated 28 October 2020 in relation to the Thirty-Seventh Annual General Meeting (“**37th AGM**”) of the Company.

On 7 November 2020, the Government of Malaysia has announced further extension of the Conditional Movement Control Order (“**CMCO**”) from 9 November 2020 to 6 December 2020 across all states in Peninsular Malaysia except for Perlis, Pahang and Kelantan to curb the spread of Coronavirus Disease (“**Covid-19**”) infection in Malaysia.

In view of the above and as part of the safety measures to curb the spread of COVID-19, the Board of Directors of the Company has decided that the 37th AGM of the Company will be conducted on a **FULLY VIRTUAL BASIS** through live streaming from the broadcast venue (as set out below) and online remote voting which is align with the Guidance and FAQs on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020 and its subsequent revision. For the avoidance of doubts, a physical 37th AGM of the Company will no longer be applicable.

Other than the changes as set out below, all the details and Agenda items as stated in the Notice of the 37th AGM of the Company shall remain unchanged:

Kindly take note that the broadcast venue is strictly for the purpose of compliance with Section 327(2) of the Companies Act 2016, which stipulates that the Chairman shall be at the main venue of the 37th AGM of the Company, and in accordance with Clause 99 of the Company’s Constitution, which allows a general meeting to be held at more than one (1) venue using any technology or method that enables the members of the Company to participate and to exercise the members’ rights to speak and vote at the general meeting. **NO SHAREHOLDERS** should be physically present or admitted at the broadcast venue on the day of the 37th AGM of the Company.

Dear Shareholders,

As a precautionary measure amid COVID-19 outbreak, the Company's forthcoming Annual General Meeting ("AGM") will be conducted virtually on our Meeting Platform, as the safety of our members, Directors, staff and other stakeholders who will attend the AGM is of paramount importance to us.

In line with the Malaysian Code on Corporate Governance Practice 12.3, by conducting a virtual AGM, this would facilitate greater shareholder participation as it facilitates electronic voting and remote shareholders' participation. With the Virtual Meeting Facilities, you may exercise your right as a member of the Company to participate (including to pose questions to the Board of Directors and/or Management of the Company) and vote at the AGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the AGM.

Kindly ensure that you are connected to the internet at all times in order to participate and vote when our virtual AGM has commenced. Therefore, it is your responsibility to ensure that connectivity for the duration of the meeting is maintained. Kindly note that the quality of the live webcast is dependent on the bandwidth and stability of the internet connection of the participants.

A. Broadcast Venue

Shareholders are **NOT ALLOWED** to participate the AGM via the Broadcast Venue as the venue is only meant to facilitate the conduct of the virtual AGM. Shareholders whom turn up at the Broadcast Venue would be requested to leave the venue politely.

B. Entitlement to Participate in the AGM

In respect of deposited securities, only members whose names appear on the Record of Depositors on **10 December 2020** (General Meeting Record of Depositors) shall be eligible to participate in the meeting or appoint proxy(ies) to participate on his/her behalf.

C. Form(s) of Proxy

If you are unable to attend the AGM, you are encouraged to appoint a proxy or the Chairman of the Meeting as your and indicate the voting instructions in the Proxy Form in accordance with the notes and instructions printed therein.

Please ensure that the original form is deposited at our Share Registrar’s office not less than forty-eight (48) hours before the time appointed for holding the meeting. Details of our Share Registrar’s office can be found in the enquiry section of this document.

Alternatively, you may deposit your proxy form(s) by electronic means through the smart investor portal at <https://boardroomlimited.my> by logging in and selecting “E-PROXY LODGEMENT”.

D. Revocation of Proxy



If you have submitted your Form(s) of Proxy and subsequently decide to appoint another person or wish to participate in our electronic AGM by yourself, please write in to bsr.helpdesk@boardroomlimited.com to revoke the earlier appointed proxy forty-eight (48) hours before the meeting.

E. Voting Procedure

Pursuant to Clause 104 of the Constitution of the Company and Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, voting at the AGM will be conducted by poll. Poll administrator and Independent Scrutineers will be appointed to conduct the polling process and verify the results of the poll respectively.
