NOTIFICATION TO SHAREHOLDERS ON THE CHANGE OF NOTICES FOR THE FORTY-NINTH ANNUAL GENERAL MEETING ("49<sup>TH</sup> AGM") AND EXTRAORDINARY GENERAL MEETING ("EGM") OF KESM INDUSTRIES BERHAD ("COMPANY")

This is line with the *Guidance and FAQs on the Conduct of General Meetings for Listed Issuers* issued by the Securities Commission Malaysia.

Kindly note that it is your responsibility to ensure that the stability of the internet connectivity throughout the 49<sup>th</sup> AGM and EGM are maintained, as the quality of the live webcast and online remote voting are dependent on the bandwidth and stability of the participant's internet connection.

#### **ENTITLEMENT TO PARTICIPATE AND VOTE**

In respect of deposited securities, only shareholders whose names appear on General Meeting Record of Depositors shall be eligible to attend the 49<sup>th</sup> AGM and EGM and/or appoint proxy(ies)/corporate representative(s) to participate and/or vote on his/her/its behalf.

#### PROXY AND PROXY FORM

In accordance to the Company's Constitution, shareholders are entitled to vote electronically at the 49<sup>th</sup> AGM and EGM either personally or by Proxy. As the 49<sup>th</sup> AGM and EGM will be conducted in a fully virtual mode, a shareholder who is unable to participate in the 49<sup>th</sup> AGM or EGM is encouraged to appoint the Chairman of the Meetings as his/her proxy(ies) and indicate his/her specific voting instructions clearly in the Proxy Form.

The Company shall be entitled to reject a Proxy Form if it is incomplete, improperly completed or illegible or where the true intentions of the shareholder are not ascertainable from the instructions specified in the Proxy Form.

#### **VOTING PROCEDURES**

- In accordance with Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, the voting at the virtual 49<sup>th</sup> AGM and EGM will be conducted by poll. The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting ("e-Voting") and GovernAce Advisory & Solutions Sdn. Bhd. as the Scrutineers to verify the poll results.
- During the virtual meetings, the Chairman of the Meetings will invite the Poll Administrator to brief on the e-Voting housekeeping rules. The voting session will commence as soon as the Chairman calls for the poll to be opened and until such time when the Chairman of the Meetings announces the closure of the poll for each Resolution.
- E-Voting for each of the resolutions as set out in the Notice of 49<sup>th</sup> AGM and EGM will take place upon the conclusion of the deliberations or Questions and Answers session of all business transacted at the 49<sup>th</sup> AGM and EGM.
- The Chairman of the Meetings will declare the poll results upon completion of the polling for all the resolutions.
