NOTIFICATION TO SHAREHOLDERS ON THE CHANGE OF MODE FOR THE TWENTY-FIFTH ANNUAL GENERAL MEETING ("25TH AGM") OF RUBBEREX CORPORATION (M) BERHAD ("RUBBEREX" OR "THE COMPANY")

## **REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")**

Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 25th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("TIIH") via its **TIIH Online** website at <u>https://tiih.online</u>.

Members who appoint proxies to participate via RPV in the 25th AGM must ensure that the duly executed Proxy Form or other instruments of appointment are deposited in a hard copy form at the Company's Share Registrar at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia or its Customer Service Counter, Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia not later than **10.00 a.m. on Wednesday**, **26 May 2021**.
