NOTIFICATION TO SHAREHOLDERS ON A FULLY VIRTUAL THIRD ANNUAL GENERAL MEETING

We refer to the announcement made on 7 May 2021 in relation to the Notice of the Third Annual General Meeting (“3rd AGM”) of Aimflex Berhad (“AIMFLEX”) to be held at Dewan Inderaputera Suites, Pulau Springs Resort Johor, Jalan Pontian Lama, 81100 Johor Bahru, Johor on Thursday, 17 June 2021 at 10.00 a.m.

On 28 May 2021, the Government of Malaysia announced a full lockdown in Malaysia starting from 1 June 2021 to 14 June 2021 (“FMCO”). As a result of the implementation of the FMCO, the Securities Commission Malaysia had on 1 June 2021, revised the Guidance Notes and Frequently Asked Questions (“FAQs”) on the conduct of General Meetings for Listed Issuers which was first issued on 18 April 2020, to require all meeting participants of a fully virtual general meeting including the Chairperson of the meeting, board members, senior management and shareholders to participate in the meeting online. Physical gatherings no matter how small are prohibited. An online meeting platform can be recognised as the meeting venue or place under Section 327(2) of Companies Act 2016 if the online platform is located in Malaysia.

The Board of Directors of AIMFLEX wishes to announce that the Company has decided that the 3rd AGM shall be conducted on a fully virtual basis through online meeting platform of TIIH Online via its website at <https://tiih.online>. Save and except for the meeting venue and the meeting platform as set out below, all details of the AGM shall remain unchanged and the Notice of AGM together with the accompanied Form of Proxy shall remain valid.

MODE OF MEETING

In line with the Government of Malaysia’s directive and the revised Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers issued by Securities Commission Malaysia as of 1 June 2021 to curb the spread of COVID-19, the Company has changed the venue of Third Annual General Meeting (“3rd AGM”) **from physical meeting to a FULLY VIRTUAL BASIS through live streaming from online meeting platform** provided by Tricor Investor & Issuing House Services Sdn Bhd in Malaysia via TIIH Online website at <https://tiihonline>. All meeting participants including the Chairperson of the meeting, board members, senior management and shareholders are required to participate in the meeting online. Physical gatherings no matter how small are prohibited.

Due to the constant evolving COVID-19 situation in Malaysia, we may be required to change the arrangements of our 3rd AGM at short notice. Kindly check the Company’s website or announcements for the latest updates on the status of the 3rd AGM.

The Company will continue to observe the guidelines issued by the Government of Malaysia, Ministry of Health, Malaysian National Security Council, Securities Commission Malaysia and/or other relevant authorities, and will take all relevant precautionary measures as advised.

REMOTE PARTICIPATION AND VOTING (“RPV”) FACILITIES

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, “participate”) remotely at the 3rd AGM using RPV facilities from Tricor.

Read and agree to the Terms & Conditions and confirm the Declaration. Select “Register for Remote Participation and Voting” Review your registration and proceed to register System will send an e-mail to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as at 10 June 2021, the system will send you an e-mail after 15 June 2021 to approve or reject your registration for remote participation. <p><i>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).</i></p>

ii	Participate through Live Streaming	<ul style="list-style-type: none"> Select the corporate event: “(LIVE STREAM MEETING) AIMFLEX BERHAD 3RD AGM” to engage in the proceedings of the AGM remotely. If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by remote participants during the AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
iii	Online Remote Voting	<ul style="list-style-type: none"> Voting session commences from 10.00 a.m. on Thursday, 17 June 2021 until a time when the Chairman announces the end of the session. Select the corporate event: “(REMOTE VOTING) AIMFLEX BERHAD 3RD AGM” or if you are on the live stream meeting page, you can select “GO TO REMOTE VOTING PAGE” button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
iv	End of remote participation	<ul style="list-style-type: none"> Upon the announcement by the Chairperson on the closure of the AGM, the Live Streaming will end.

Note to users of the RPV facilities:

- Should your application to join the meeting be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

Entitlement to Participate and Appointment of Proxy

- In view that the AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the AGM yourself, please do not submit any Proxy Form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you.
