### NOTIFICATION TO SHAREHOLDERS ON THE CHANGE OF MODE AND VENUE FOR THE TWENTY SIXTH ANNUAL GENERAL MEETING ("26TH AGM") OF WATTA HOLDING BERHAD ("WATTA")

On 27 April 2021, WATTA had announced its 26th AGM scheduled to be held on Wednesday, 30 June 2021 at 9.00 a.m. at Alhambra Ballroom, Level M1, Hotel Melia Kuala Lumpur, 16, Jalan Imbi, 55100 Kuala Lumpur, Malaysia. On 28 May 2021, the Government of Malaysia had announced a full lockdown in Malaysia starting from 1 June 2021 to 14 June 2021 ("FMCO") and had on 11 June 2021 announced a further extension of FMCO from 15 June 2021 to 28 June 2021.

As a result of the implementation of the FMCO, the Securities Commission Malaysia has further revised its *Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers* ("Revised Guidance Note and FAQ") to state that effective 1 June 2021, when a listed issuer conducts its general meeting during FMCO, the listed issuer is only allowed to conduct a fully virtual general meeting where all meeting participants including the Chairperson of the meeting, board members, senior management and shareholders are required to participate in the meeting online. Physical gatherings no matter how small are prohibited.

According to the Revised Guidance Note and FAQ, an online meeting platform can be recognised as the meeting venue or place under Section 327(2) of Companies Act 2016 provided that the online platform is located in Malaysia.

The Board of Directors of WATTA ("Board"), having given due consideration to the above and as part of the safety measures, wishes to inform that the 26th AGM of WATTA will be conducted on a fully virtual basis via the online meeting platform provided by Tricor Investor & Issuing House Services Sdn. Bhd. via *TIIH Online* at <a href="https://tiih.online">https://tiih.online</a>. Kindly refer to the Administrative Guide for the 26th AGM stated below and also published on the Company's website at <a href="http://www.watta.com.my/agm-documents-annual-report.html">http://www.watta.com.my/agm-documents-annual-report.html</a> for more information on the registration process.

## ADMINISTRATIVE GUIDE FOR THE 26TH AGM OF WATTA HOLDING BERHAD

### REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 26th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <a href="https://tiih.online">https://tiih.online</a>.

Shareholders who appoint proxies to participate via RPV in the 26th AGM must ensure that the duly executed forms of proxy are deposited in a hard copy form or by electronic means to Tricor no later than **Monday, 28 June 2021 at 9.00 a.m.** 

Representatives of corporate members (corporate representatives) must deposit their original certificate of appointment of corporate representative to Tricor not later than **Monday**, **28 June 2021 at 9.00 a.m.** to participate via RPV in the 26th AGM.

Attorneys appointed by power of attorney must deposit their powers of attorney with Tricor not later than **Monday, 28 June 2021 at 9.00 a.m.** to participate via RPV in the 26th AGM.

Shareholder who has appointed a proxy or authorised representative or attorney to participate at the 26th AGM via RPV must request his/her proxy/authorised representative/attorney to register himself/herself for RPV at *TIIH Online* website at <u>https://tiih.online</u>.

As the 26th AGM of WATTA will be held on a fully virtual basis, shareholders who are unable to participate in this 26th AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the form of proxy.

		•	Indicate your votes for the resolutions that are tabled for voting.
		•	Confirm and submit your votes.
(f)	End of remote participation	•	Upon the announcement by the Chairman on the closure of the 26th AGM, the Live Streaming will end.

### Note to users of the RPV:

- 1. Should your application to join the 26th AGM be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to *TIIH Online* on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

## POLL VOTING

- The voting at the 26th AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.
- Shareholders/proxies/authorised representatives/attorneys can proceed to vote on the resolutions at any time from the commencement of the 26th AGM at 9.00 a.m but before the end of the voting session, which will be announced by the Chairman of the meeting. Kindly refer to item (e) of the above Procedures for RPV for guidance on how to vote remotely from *TIIH Online* website at <a href="https://tiih.online">https://tiih.online</a>.
- Upon completion of the voting session for the 26th AGM, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
