

NOTIFICATION TO SHAREHOLDERS IN RELATION TO THE CHANGE OF BROADCAST VENUE FOR THE SEVENTH ANNUAL GENERAL MEETING ("7<sup>TH</sup> AGM") OF KRONOLOGI ASIA BERHAD ("KAB" OR "THE COMPANY") TO THE ONLINE MEETING PLATFORM DUE TO THE EXTENSION OF THE FULL MOVEMENT CONTROL ORDER ("FMCO")

Dear Valued Shareholders of KAB,

The Company had on 31 May 2021 issued the notice of the 7<sup>th</sup> AGM scheduled to be held on fully virtual basis and entirely via remote participation and voting at the Broadcast Venue at Conference Room of Kronologi Asia Berhad, Level 28-D, Axiata Tower, No.9 Jalan Stesen Sentral 5, KL Sentral, 50470 Kuala Lumpur on Tuesday, 29 June 2021 at 2:30 p.m. or at any adjournment thereof.

The Government of Malaysia had on 28 May 2021 announced the implementation of the FMCO in Malaysia for fourteen (14) days beginning from 1 June 2021 to 14 June 2021 and subsequently, had on 11 June 2021 announced the extension of the FMCO for another fourteen (14) days with effect from 15 June 2021 to 28 June 2021 in order to contain the spread of the COVID-19 outbreak.

Following the implementation of the FMCO, the Securities Commission Malaysia has further revised its Guidance Note and FAQs on the conduct of General Meetings for Listed Issuers ("Revised Guidance Note and FAQ") to state that effective from 1 June 2021, when a listed issuer conducts its general meeting during FMCO, the listed issuer is only allowed to conduct a fully virtual general meeting where all meeting participants including the Chairman of the meeting, board members, senior management and shareholders are required to participate in the meeting online. Physical gatherings no matter how small are prohibited. According to the Revised Guidance Note and FAQ, an online meeting platform can be recognised as the meeting venue or place under Section 327(2) of Companies Act 2016 provided that the online platform is located in Malaysia.

Having given due consideration to the above, the Board of Directors of the Company wishes to inform that the Broadcast Venue of the 7<sup>th</sup> AGM of the Company shall be changed to the online meeting platform of TIIH Online provided by Tricor Investor & Issuing House Services Sdn. Bhd. via its website at https://tiih.online as scheduled.

Save for the change of Broadcast Venue to the online meeting platform, all information in the Notice of the 7<sup>th</sup> AGM of the Company dated 31 May 2021, Proxy Form and the Administrative Guide for the 7<sup>th</sup> AGM, shall remain unchanged.

Due to the constantly evolving COVID-19 situation in Malaysia, we may be required to change the arrangements of the 7<sup>th</sup> AGM at short notice. Kindly check Bursa Malaysia Securities Berhad's and Company's website for the latest updates on the status of the 7<sup>th</sup> AGM.
