## NOTIFICATION TO SHAREHOLDERS ON THE CHANGE OF VENUE OF THE NINETY-FOURTH ANNUAL GENERAL MEETING TO ONLINE MEETING PLATFORM

Dear Shareholders of Eastern & Oriental Berhad ("the Company")

On 27 July 2021, the Company had issued Notice of the Ninety-Fourth Annual General Meeting ("94<sup>th</sup> AGM") to be conducted on a fully virtual basis through live streaming and online remote voting from the broadcast venue at Tricor Business Centre, Manuka 2 & 3 Meeting Room, Unit 29-01, Level 29, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia.

In view of the implementation of the Phase 1 of the National Recovery Plan and pursuant to the revised Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers issued by Securities Commission Malaysia on 16 July 2021, listed issuers are only allowed to conduct fully virtual general meetings during this period. In a fully virtual general meeting, all meeting participants including the Chairperson of the meeting, board members, senior management and shareholders are required to participate in the meeting online. Physical meetings or gatherings, irrespective of the number of participants involved are prohibited.

According to the updated Guidance Note and FAQs, an online meeting platform can be recognised as the meeting venue or main venue under Section 327(2) of the Companies Act 2016 provided that the online meeting platform is located in Malaysia.

In line with the restriction on movement, the Company wishes to inform that the venue of the 94<sup>th</sup> AGM shall be changed to the Online Meeting Platform via TIIH Online Website at <a href="https://tiih.online">https://tiih.online</a> as provided by Tricor Investor & Issuing House Services Sdn Bhd. Malaysia.

Apart from the change in venue of meeting as stated below, all information in the Notice of the 94<sup>th</sup> AGM of the Company, the Form of Proxy and Administrative Guide issued on 27 July 2021 remain unchanged.
