

## NOTIFICATION ON THE CHANGE OF BROADCAST VENUE OF THE POSTPONED FORTY-NINTH ANNUAL GENERAL MEETING ("49TH AGM")

Dear Shareholders,

We refer to our earlier announcements made on 28 April 2021, 15 June 2021 and 24 August 2021 in relation to the notice of the 49<sup>th</sup> AGM of the Company and its postponement.

The Government of Malaysia had on 8 September 2021 announced that Selangor, Kuala Lumpur and Putrajaya will be transited to Phase 2 of the National Recovery Plan ("NRP") effective from 10 September 2021. Following the transition into Phase 2 of the NRP and after taking into account the provision and facilitation of a better and meaningful engagement with shareholders at the Postponed 49<sup>th</sup> AGM of the Company to ensure seamless experience to shareholders, the Board of Directors of the Company wishes to inform that the Postponed 49<sup>th</sup> AGM of the Company will be **conducted virtually via Remote Participation and Voting ("RPV") facilities** at the Broadcast Venue as set out below:-
