#### Explanatory Notes On Special Business

- The Ordinary Resolutions proposed under item 6, if passed, will authorise Dr Wong Hong Meng and Puan Farizon binti Ibrahim to continue to act as Independent Non-Executive Directors of the Company until the conclusion of the next AGM of the Company.
- The Nomination Committee, with Dr Wong Hong Meng and Puan Farizon binti Ibrahim abstaining from the deliberation of their own assessment, had assessed the independence of Dr Wong Hong Meng and Puan Farizon binti Ibrahim who have served on the Board as Independent Non-Executive Directors of the Company for a cumulative term of more than 9 years, and yoon its recommendation, the Board was satisfied that Dr Wong Hong Meng and Puan Farizon binti Ibrahim have met the independence guidelines as set out in Chapter 1 of Bursas Securities Main Market Listing Requirements. The length of their service does not interfere with Dr Wong Hong Meng's and Puan Farizon binti Ibrahim's ability and exercise of independent judgement as Independent Directors.
- 2. The Ordinary Resolution proposed under item 7 is a renewal of the general authority for the Directors to issue shares pursuant to Sections 75 and 76 of the Companies Act 2016. If passed, it will empower the Directors of the Company, from the date of the above 38th AGM until the next AGM to allot and issue shares in the Company up to and not exceeding in total 10% of the total number of issued shares of the Company. This authority will expire at the next AGM of the Company, unless revoked or varied at a general meeting.

The Company has not issued any new shares under the general authority which was approved at the 37th AGM held on 10 December 2020 and which will lapse at the conclusion of the 38th AGM to be held on 9 December 2021.

The general authority to issue shares will allow the Company to take advantage of any strategic opportunities, including but not limited to, issuance of new shares for purpose of funding investment project(s), working capital and/or acquisitions which require new shares to be allotted and issued speedily and would also save the cost involved in convening a general meeting to approve such issuance of shares.
