- The instrument appointing a proxy shall be in writing under the hand of the appointer or his attorney duly authorised in writing and in the case of a corporate member, either under its common seal or under the hand of an officer or attorney duly authorised. (5)

#### 1. Audited Financial Statements for the financial year ended 30 June 2023

The Agenda 1 is meant for discussion only as Section 340(1)(a) of the Companies Act, 2016 provide that the audited financial statements are to be laid in the general meeting and do not require a formal approval of the shareholders. Hence, this Agenda item is not put forward for voting.

2. Ordinary Resolutions 1 & 2 : To approve the payment of Directors' Fees and other benefits payable

Pursuant to Section 230(1) of the Act, fees and benefits payable to the Directors of public company or a listed company and its subsidiaries shall be approved by shareholders at a general meeting. The Directors' benefits payable comprises of meeting attendance allowances and other claimable benefits.

In determining the estimated total amount of Directors' benefits, the Board has considered various factors, among others, the estimated claimable benefits and estiin number of meetings for the Board and Board Committees held for the period commencing from the conclusion of the 16th AGM until the next AGM of the Company In the event the proposed amount is insufficient (e.g. due to more meetings or enlarged Board size), approval will be sought at the next AGM for additional fees to meet the shortfall.

#### 3. Ordinary Resolutions 3 & 4 : Re-election of Directors who retire by rotation in accordance with Clause 125 of the Company's Constitution

Clause 125 of the Company's Constitution states that an election of Directors shall take place each year during the annual general meeting. At the first annual general meeting of the Company, all the Directors shall retire from office, and at the annual general meeting in every subsequent year, one-third of the Directors shall retire from office once in every three (3) years or, if their number is not three (3) or a multiple of three (3), the number nearest to one-third (1/3) shall retire from office such that each Director shall retire from office once in every three (3) years, and if there is only one (1) Director who is subject to subject the place of the form office once in every three (3) years, and if there is only one (1) Director who is subject to the place of the form office once in every three (3) years. to retirement by rotation, he shall retire. All Directors who retire from office shall be eligible for re-election

Noor Shahwan Bin Saffwan and Kong Wei Peng are standing for re-election as Directors of the Company and being eligible, have offered themselves for re-election

For the purpose of determining the eligibility of the Directors to stand for re-election at the 16<sup>th</sup> AGM, the Nomination Committee has considered and recommended Noor Shahwan Bin Saffwan and Kong Wei Peng for re-election as Directors pursuant to Clause 125 of the Company's Constitution.

# Ordinary Resolution 6 - Authority to Allot Shares Pursuant to Sections 75 and 76 of the Act

The proposed Ordinary Resolution 6 is the renewal of the general mandate from the shareholders at the 15th Annual General Meeting held on 29 November 2022 ("the Previous Mandate").

The proposed Ordinary Resolution 6, if passed, is a renewal of general mandate to the Directors of the Company to issue and allot shares at any time to such persons in their absolute discretion without convening a general meeting as it would be time consuming to organise a general meeting. The general mandate will provide flexibility and expediency to the Company for any possible fund-raising activities involving the issuance or placement of shares to facilitate business expansion or strategic merger and acquisition opportunities involving equity deals or part equity or to fund future investment project(s) or working capital requirements, which the Directors of the Company consider to be in the best interest of the Company. The general mandate, unless revoked or varied at general meeting, will expire at the next Annual General Meeting of the Company. the Company

Unless revoked or varied by the Company in a general meeting, this authority will expire at the conclusion of the next Annual General Meeting of the Company.

## As at the date of this Notice, the Company has yet to issue any shares pursuant to the Previous Mandate granted to the Directors at the 15th AGM. Ordinary Resolution 7 - Proposed New and Renewal of Shareholders' Mandate for RRPTs of a Revenue or Trading Nature

The proposed Ordinary Resolution 7, if passed, will provide a renewal mandate for the Company and/or its subsidiaries to enter into recurrent related party transactions of a revenue or trading nature with Related Parties in the ordinary course of business based on commercial terms which are not more favourable to the Related Parties than those generally available to the public and which are necessary for the Group's day-to-day operations. This mandate shall lapse at the conclusion of the next AGM unless authority for the renewal is obtained from the shareholders of the Company at general meeting.
