AS ORDINARY BUSINESS

- 1. To receive the Audited Financial Statements for the financial year ended 29 February 2024 together with the Directors' and Auditors' Reports thereon.
- 2. To approve the payment of Directors' fees and benefits up to the amount of RM400,000 for the financial year ending 28 February 2025
- To approve the payment of the Final Single Tier Dividend of 1.50 sen per ordinary share for the financial year ended 29 February 2024.

To consider, and if thought fit, to pass the following Ordinary Resolutions:

6. AUTHORITY TO ISSUE SHARES BY THE COMPANY PURSUANT TO SECTIONS 75 AND 76 OF THE COMPANIES ACT 2016

"THAT subject always to the Companies Act 2016 ("the Act"), and approvals from any other governmental/regulatory authorities, the Directors of the Company be and are hereby empowered, pursuant to Sections 75 and 76 of the Act, to issue shares in the Company at any time and upon such terms and conditions and for such purposes as the Directors of the Company may, in their absolute discretion, deem fit provided that the aggregate number of shares to be issued pursuant to this resolution does not exceed 10% of the total number of issued shares of the Company at the time of submission to the authority AND THAT the Directors of the Company be and are hereby empowered to obtain the approval for the listing of and quotation for the additional shares so issued on Bursa Malaysia Securities Berhad ("Bursa Securities") AND FURTHER THAT such authority shall continue to be in force until the conclusion of the next Annual General Meeting of the Company.

AND THAT pursuant to Section 85 of the Act read together with Article 17.4 of the Constitution of the Company, approval be and is hereby given to waive the statutory emptive rights of the shareholders of the Company to be offered new shares ranking equally to the existing issued shares arising from any issuance of new shares pursue to Sections 75 and 76 of the Act.

AND THAT the new shares to be issued shall, upon allotment and issuance, rank equally in all respects with the existing shares of the Company, save and except that they shall not be entitled to any dividends, rights, allotments and/or any other forms of distribution that which may be declared, made or paid before the date of allotment of such new shares."

PROPOSED RENEWAL OF SHARE BUY-BACK AUTHORITY

"THAT subject to compliance with all applicable rules, regulations and orders made pursuant to the Act, provisions in the Company's Constitution, the Listing Requirement of Bursa Securities and any other relevant authorities, the Company be and is hereby authorised to purchase such number of ordinary shares of the Company ("Propose Renewal of Share Buy-Back") as may be determined by the Directors of the Company from time to time through Bursa Securities upon such terms and conditions as th Directors may deem fit and expedient in the interest of the Company PROVIDED THAT:

the aggregate number of shares purchased or held does not exceed ten per centum (10%) of the total number of issued shares of the Company as quoted on Bursa Securities as at the point of purchase; (1)

- (2) the maximum fund to be allocated by the Company for the purpose of purchasing such number of ordinary shares shall not exceed the retained profit account of the Company. As at the latest financial year ended 29 February 2024, the audited retained profit account of the Company stood at RM44,464,527;
- the authority conferred by this resolution will commence immediately upon passing of this resolution and will continue to be in force until: (3)
- (a) at the conclusion of the next Annual General Meeting ("AGM") of the Company following the general meeting in which the authorisation is shall lapse unless by ordinary resolution passed at that meeting, the authority is renewed either unconditionally or subject to conditions; o is obtained, at which time it
 - the expiration of the period within which the next AGM of the Company is required by law to be held; or (b)
 - (c) revoked or varied by ordinary resolution passed by the shareholders of the Company in a general meeting

whichever occurs first;

AND THAT upon completion of the purchase(s) of the ordinary shares of the Company, the Directors of the Company be and are hereby authorised to deal with the ordinary shares so purchased in the following manner:

- to cancel the ordinary shares so purchased; or to retain the ordinary shares so purchased as treasury shares for distribution as dividend to shareholders and/or resell on Bursa Securities or subsequently cancelled; or to retain part of the ordinary shares so purchased as treasury shares and cancel the remainder; or in any other manner prescribed by the Act, rules, regulations and orders made to the Act, the Listing Requirements of Bursa Securities and any other relevant authorities for the time being in force. AND THAT the Board of the Company be and are hereby authorised to take all such steps as are necessary or expedient to implement, finalise or to effect the aforesaid share buy-back with full powers to assent to any conditions, modifications, variations, and/or amendments as may be required or imposed by the relevant authorities and to do all such acts and things (including executing all documents) as the Board may deem fit and expedient in the best interest of the Company."

- This Agenda item is meant for discussion only as under the provisions of Section 340(1)(a) of the Companies Act 2016, the audited financial statements do not require the approval of the shareholders. As such, this matter will not be put forward for voting.
- Ordinary Resolution No. 1: Payment of Directors' Fees & Benefits

Pursuant to Section 230(1) of the Companies Act 2016, the shareholders' approval is sought for the proposed payment of Directors' Fees for financial year ending 28 February 2025 and Benefits to the Non-Executive Directors ("NEDs"). The calculation of the benefits which include meeting allowance is based on the estimated number of scheduled and/or special Board and Board Committees' meetings and on the assumption that the number of NEDs in office until the next AGM remains the same.

- 10. Ordinary Resolutions No. 3, 4 and 5: Re-election of Directors
- Article 26.1 of the Company's Constitution provides that an election of Directors shall take place each year at the annual general meeting of the Company where one third (1/3) of the Directors for the time being, or, if their number is not three (3) or a multiple of three (3), then the number nearest to one third (1/3) shall retire from office and be eligible for re-election. PROVIDED ALWAYS THAT all Directors shall retire from office once at least in each three (3) years but shall be eligible for an election. lection

The Board through its Nominating Committee had assessed each of the retiring Directors, and considered the following factors in determining their eligibility for re-election:

- (a) the required mix of skills and experience;
 (b) the character, knowledge, expertise, professionalism, integrity and time availability;

- the ability to discharge such responsibilities and functions as expected as Director; a attendance at Board and Committee Meetings
- The profiles of the Directors standing for re-election are set out in the Directors' Profile of the al Report 2024

11. Ordinary Resolution No. 6: Re-appointment of Auditors

The Board and Audit Committee had at their respective meetings on 25 April 2024 recommended the re-appointment of Grant Thornton Malaysia PLT for the financial year ending 28 February 2025. Grant Thornton Malaysia PLT have met the criteria prescribed under the Paragraph 15.21 of the Main Market Listing Requirements and indicated their willingness to continue their services for the next financial year.

Ordinary Resolution No. 7: Authority under Sections 75 And 76 of the Act

The Company had during its 17th AGM held on 26 July 2023 obtained from its sharehod a general mandate pursuant to Sections 75 and 76 of the Act to issue and allot shares Company up to 10% of the total number of issued shares of the Company and this ma had not been exercised by the Company.

The proposed Ordinary Resolution 7 is a renewal mandate of the general mandate for the issuance of shares by the Company under Sections 75 and 76 of the Act. Pursuant to Section 85 of the Act and Article 17.4 of the Company's Constitution, shareholders have pre-emptive rights to be offered any new shares in the Company which rank equally to the existing issued shares in the Company. This Ordinary Resolution 7, if passed, will exclude the shareholders' pre-emptive right to be offered new shares to be issued by the Company.

This authority, unless revoked or varied by the Company in a general meeting, will expire at the conclusion of the next AGM of the Company. This mandate would provide the Company the flexibility to raise fund, including but not limited to placing of shares to finance future investment(s), project(s), acquisition(s) and/or working capital without having to convene a general meeting.

13. Ordinary Resolution 8 - Proposed Renewal of Share Buy-Back Authority

This resolution will empower the Directors of the Company to purchase the Company's shares up to ten per centum (10%) of the total number of issued shares of the Company by utilising the funds allocated which shall not exceed the total retained profits of the Company. This authority, unless revoked or varied at a general meeting, will expire at the conclusion of the next AGM of the Company. the Company
