# NOTES TO THE UNAUDITED INTERIM FINANCIAL REPORT FOR THE THIRD QUARTER ENDED 30 SEPTEMBER 2007

## A. Explanatory Notes Pursuant to Financial Reporting Standard ("FRS") No.1342004

### A1 Basis of Preparation

The interim financial statements are unaudited and have been prepared in accordance with the applicable disclosure provisions of rule 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad for the MESDAQ Market and in compliance with the requirements of FRS 134<sub>2004</sub>, Interim Financial Reporting, issued by the Malaysian Accounting Standards Board.

The Group's revenue for the third quarter and nine (9) months financial period ended 30 September 2007 have increased by approximately 5.2% and 3.9% respectively, as compared to the preceding year's corresponding period in the preceding financial year. The increases in revenue were mainly contributed by the improved performances from the retail outlets and branches.

The Group recorded profit before taxation of approximately RM264,000 and RM605,000 for the third quarter and nine (9) months financial period ended 30 September 2007 respectively as compared to the losses before taxation for the corresponding period in the preceding financial year of approximately RM318,000 and RM942,000. The improved performance were mainly due to improved gross profit margin and the consolidation of some operation to reduce the overheads.

During the financial quarter under review, the Group recorded a profit before taxation of approximately RM264,000 as compared to a profit before taxation of approximately RM386,000 for the preceding quarter ended 30 June 2007. This is mainly due to the reduced gross profit margin achieved during the quarter owing to market competition.

## **B3** Commentary on Prospects

The Group have strategically consolidated the operations of the "ESYINK" range of IT consumable products viz. compatible ink cartridges and coated paper. The move has enabled an effective business focus on the more stable range of products in terms of profitability. The Group will continue to draw on the strength of a ready network of distribution/retail outlets throughout the country with the aim of maintaining the "ESYINK" brand leadership in the compatible ink market of the country.

In view of the discouraging prospect of the Micro Floppy Diskettes ("MFD") sector, the Group has in the mean time reduced the operations to a minimal level while aiming to relocate or dispose of the MFD manufacturing activity in the near future.

The Group hopes to benefit from the country's improving economic fundamentals and resilient domestic demand. This is expected to impact positively on the retailing sector of IT products. Barring unforeseen circumstance, the Board is optimistic that the Group's core division of trading and retailing will contribute positively to the performance of the Group.
