A. EXPLANATORY NOTES

A1 BASIS OF PREPARATION OF THE FINANCIAL STATEMENTS

The interim financial statements are unaudited and have been prepared in accordance with the Malaysian Financial Reporting Standard ("MFRS")134 - Interim Financial Reporting and Chapter 9, Part K Rule 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad ("Securities Exchange") for the ACE Market, and should be read in conjunction with the Group's annual audited financial statements for the financial year ended 31 December 2011. The accounting policies and methods of computation adopted by the Group in the interim unaudited financial statements are consistent with those adopted for the financial year ended 31 December 2011.

B1 Review of performance

For the current financial quarter under review ("Q2 2012"), the Group recorded total revenue of RM4,812,853 and profit before taxation ("PBT") of RM359,998 as compared to revenue of RM3,860,662 and PBT of RM 468,314 reported in preceding corresponding quarter. The efforts in developing new technology and branding of biometric products continue to improve this quarter's revenue figures. The decrease of PBT was mainly due to obsolete stock valued at RM232k.

B2 Variation of results against preceding quarter

For Q2 2012, the Group reported total revenue of RM4,812,853 and PBT of RM359,998 as compared to revenue and PBT of RM4,293,343 and RM559,718 respectively in the preceding quarter (Q1 2012). The decrease of approx. RM199,720 in PBT was mainly due to obsolete stock valued at RM232k.

B3 Prospects

For the year 2012, the Group expects Biometric industry to be more challenging due to the volatility of the global economy. Nevertheless, the Group will continue to develop its technology and branding to improve customer satisfactions and remain competitive in the market.

B8 Status of corporate proposals

On 16 November 2010, the Company had entered into a conditional Share Sale Agreement ("SSA") with Redhot Media International Limited ("RMIL") for the acquisition of the entire equity interest in Red Media Asia Limited ("RMA") comprising a total of 8,269,818 ordinary shares of USD1.00 each for a total consideration of RM95.0 million to be satisfied via the issuance of 950,000,000 new ordinary shares at RM0.10 each in PUC ("shares").

On 11 November 2011, the Company announced to extend the Conditional Period for a further six (6) months from 14 November 2011 until 15 May 2012 follow by the earlier announcement dated 13 May 2011 which postponed the Condional Period from 14 May to 14 November 2011. Both parties have also agreed that in the event if the conditions precedent did not fulfilled by 15 May 2012, the conditional period will be extended automatically for another six (6) months till 14 November 2012.

The announcement also included the extension of the application to the relevant authorities seeking approval for the Proposals for a further six (6) months till 11 May 2012. Consequently, the estimated timeframe for completion of the Proposals would then be further postponed to the first half of 2012.

On 24 February 2012, the Company entered into the First Supplemental SSA with RMIL in relation to the Proposed Acquisition to vary and amend some of the terms of the SSA.

On 9 April 2012, the Company submitted the application to Bursa Securities (Bursa) and Equity Compliance Unit (ECU) of Securities Commission (SC) seeking approval and notification for the Proposal. Bursa had on 7 May 2012 raised queries on the proposal. Currently the responds to Bursa's queries is under review by the Reporting Accountant.

SC via its letter dated 18 May 2012 take note of the notification submitted. The Independent Advise Letter (IAL) for Non-Interested shareholders in regards of the "Proposed Exemption" has been submitted to SC on 27 June 2012 seeking approval to be included as part of the circular.

On 17 August 2012, the Company announced that the expected timeframe for completion of the Proposals has been revised from the first half of 2012 to first guarter of 2013.

B9 Group's borrowings and debt securities

There were no Group's borrowings and debt securities as at the date of this announcement.

Proposed disposal of Myage Software (M) Sdn Bhd (formerly known as Sendi Mutiara On-line Sdn Bhd)

On 23 February 2007 PUC had filed a Writ of Summons against Wong Kok San ("Defendant") for RM287,500.00, including interest, legal charges and other relevant costs pursuant to the breach of contract arising from the sale of shares of Myage Software (M) Sdn Bhd in respect of the Share Sale Agreement ("SSA") dated 26 June 2006 entered into between PUC and the Defendant.

PUC won the case in April 2008. However the Defendant did not respond to the judgment order, thus Bankruptcy Notice has been filed against the Defendant in February 2010 and approved in January 2012.

Resulted from the Hearing of Creditor Petition on 9 July 2012, an Adjudicating Order and Receiving Order has been pronounced and the Defendant is officially declared a bankrupt. As at the date of this announcement, the extraction is still pending from Court.
