The Group's profit before taxation increased by 46.5% or from RM4.741 million to RM6.947 million is mainly due to lower cost of materials, higher operational efficiency, unrealised foreign exchange currency gain and lower finance costs for the current quarter under review as compared to the preceding year corresponding quarter.
