PART A - EXPLANATORY NOTES PURSUANT TO FRS 134

A1. BASIS OF PREPARATION

B1. REVIEW OF YEAR-ON-YEAR PERFORMANCE

For the year ended 31 December 2009, the Group recorded revenue of RM29.9 million, decreasing 3% compared to RM30.8 million posted in the corresponding period last year.

The Group registered an operating loss of RM1.2 million in the reporting quarter compared to RM2.3 million operating profit in the corresponding period last year. This result is due to lower software revenue.
