Part B – Additional Information required by Bursa Malaysia Securities Berhad's Listing Requirements

B1. Performance Review

For the quarter under review, the Group recorded revenue of approximately RM4.3 million, which was comparable to the revenue recorded for the preceding year's corresponding quarter ended 30th June 2006.

Profit before taxation for the current quarter was RM0.1 million as compared to the loss before taxation of approximately RM0.5 million for the preceding year's corresponding quarter. The improvement was mainly due to lower stock option expenses and higher margin achieved from the existing order book.

The revenue of approximately RM4.3 million achieved in the current quarter under review was comparable that achieved in the preceding quarter ended 31 March 2007. The Group recorded a profit before taxation of RM0.1 million as compared to a profit before taxation of approximately RM1.1 million in the preceding quarter as there was write-back of impairment loss on intangible asset and doubtful debt in the preceding quarter.

The Group ended the current first quarter with an order book of RM21.8 million as compared to RM16.6 million as at the end of immediate preceding quarter. The majority of the order book consists of e-government contracts.

B3. Prospect

The Group has achieved two quarters of positive EBITDA and the order book has increased from the preceding quarter. Hence, the Group expects the performance for the current financial year to be sustained.

The Group will continue its efforts to improve its operating performance and marketing in overseas markets.

B4. Profit Forecast and Profit Guarantee

The Group has not issued any profit forecast or profit guarantee.

The Company was granted Multimedia Super Corridor ("MSC") status on 29 October 2002. By virtue of this status, the Company obtained its pioneer status incentive which includes five year exemption on statutory business income under Section 127 of the Income Tax Act, 1967 which expires in January 2008.

B6. Sale of Unquoted Investments and Properties

There were no sales of unquoted investment and properties during the quarter.

B7. Quoted and marketable securities

The Group does not have any investment in quoted securities.

B8. Status of Corporate Proposals

(a) Employee Share Option Scheme ("ESOS")

At an extraordinary general meeting on 28 September 2004, the Company's shareholders approved the establishment of a ten (10) year ESOS of up to thirty percent (30%) of the issued and paid-up capital of the Company, subject to a maximum entitlement of fifteen percent (15%) for the first five (5) years to eligible Directors and employees of the Group

On 20 March 2006, a total of 17,810,000 options had been issued to eligible employees of the Group. On 21 June 2006, a total of 7,300,000 options had been issued to eligible Directors of the Group. On 30 August 2006, a total of 960,000 options had been issued to eligible employees of the Group. On 15 June 2007, another 8,440,000 options had been granted to eligible employees of the Group. As at 30 June 2007, a total of 11,865,000 options had been exercised.



(b) Private Placement Proposed private placement

On 5 March 2007, the Company proposed to implement a private placement of up to 34,517,825 new ordinary shares of RM0.10 each in the Company, representing not more than ten percent (10%) of the issued and paid-up share capital of the Company, to investors to be identified ("Private Placement"). The Securities Commission had vide their letter dated 27 March 2007 approved the Private Placement.

On 10 May 2007, additional 17,000,000 new ordinary shares of RM0.10 each issued at RM0.117 per share, being the first tranche of the Private Placement, was granted listing and quotation. The proceeds of approximately RM1.98 million had been fully utilized as the working capital of the Group as to date.

On 27 August 2007, the Board announced that it had fixed the issue price for the second tranche of shares to be issued pursuant to the Private Placement at RM0.10 for every new ordinary share of RM0.10 each. The issue price of RM0.10 represents a premium of approximately 8.81% from RM0.0919, being the five (5) days weighted average market price of the Company's shares up to and including 24 August 2007.
