

## A. Notes To The Interim Financial Report For The Quarter Ended 30 June 2010

## A1. Basis of Preparation

The interim financial statements are unaudited and have been prepared in compliance with Financial Reporting Standards ("FRS") 134 Interim Financial Reporting and Appendix 9B of the Listing Requirements of the Bursa Malaysia Securities Berhad for the ACE Market ("Bursa Securities").

The interim financial statements should be read in conjunction with the audited financial statements for the year ended 30 June 2009. These explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of Scope Industries Berhad ("SCOPE" or "Company") and its wholly-owned subsidiary companies (hereinafter referred to as the "Group") since the financial year ended 30 June 2009.

The same accounting policies and methods of computation are followed in the interim financial statements as compared with the financial statements for the financial year ended 30 June 2009 except for the adoption of FRS 8, Operating Segments issued by the Malaysian Accounting Standards Board that are effective for the Group's financial statements commencing 1 July 2009. The Group determined that the operating segments were the same as the business segments previously identified under FRS 114<sub>2004</sub> Segment Reporting.

### A2. Changes in Accounting Policies

The significant accounting policies adopted are consistent with those of the audited financial statements for the year ended 30 June 2009.

#### A3. Audit Qualification of the Preceding Annual Financial Statements

There was no qualification in the audit report of the preceding annual financial statements of the Group.

## A4. Seasonality or Cyclicality of Operations

Generally, the sales for the Group's products are higher in the first and second quarters of the financial year due to higher demand for the year end festive seasons.

There were no material unusual items affecting the assets, liabilities, equity, net income or cash flows of the Group that are unusual in nature, size or incidence for the current interim period and financial year-to-date.

# B. Additional Notes Pursuant To The Listing Requirements of Bursa Securities For the ACE Market For The Quarter Ended 30 June 2010

## B1. Review of Results for the Quarter and Year To Date

The Group recorded revenue of RM6.26 million and profit after tax of RM0.54 million for the quarter ended 30 June 2010, which represents a significant increase of 119.60% and 121.41% respectively over the corresponding quarter of the preceding year ended 30 June 2009.

The revenue for the year to date reduced to approximately RM18.27 million as compared to RM46.63 million in the preceding year to date. This was due to cessation of power transformers operation and reduction in the turnkey projects. Despite of decline in revenue, there was a gross profit of RM0.78 million for the year to date as against a gross loss of RM1.44 million in the preceding year.

The Group took an aggressive cost cutting exercise and managed to reduce the loss after taxation from RM10.59 million for the preceding year to RM4.16 million for the year to date.

## B2. Comparison With Immediate Preceding Quarter's Results

The revenue for the 4<sup>th</sup> quarter under review was approximately RM6.26 million, representing an increase of 169.96% compared to the preceding quarter. The group recorded a profit after taxation of RM0.54 million for the current quarter compared to a loss after taxation of RM1.44 million in the immediate preceding quarter mainly due to higher demand and low inventory level.

#### B3. Current Year Prospects

Barring any unforeseen circumstances, the Group is optimistic to achieve satisfactory results in next financial year.
