1. Review of Performance for the Individual Quarter and Year-to-date

For the quarter under review, PTB Group recorded a revenue of RM15.812 million, representing an increase of approximately 30% as compared to the preceding year corresponding quarter ended 31 March 2010 of RM12.156 million. Hence, the Group recorded a loss after taxation of RM0.145 million for the current quarter ended 31 March 2011 as compared to a loss after taxation of RM0.494 million for the preceding year corresponding quarter ended 31 March 2010. The decrease in loss after taxation was mainly due to higher demand of the Group's products

2. Comparison with previous quarter's results

For the current quarter ended 31 March 2011, the Group recorded a revenue of RM15.812 million, representing a increase of approximately 25.94% as compared to the previous quarter ended 31 December 2010 of RM12.555 million. The Group recorded a loss after taxation of RM0.145 million in the current quarter ended 31 March 2011 compared to the previous quarter ended 31 December 2010 of profit after taxation of RM0.334 million. The decrease in profit after taxation was mainly due to the adjustment of deferred taxation in the previous quarter, higher materials cost and lower contribution from Associate Company in the current quarter.

3. Current Year's Prospect

The Board of Directors of PTB is of the view that the Group's financial performance for the financial year ending 2011 will be more encouraging in the light of the current level of operations and prevailing market conditions. The Group will still maintain its best effort to ensure the business of the Group remains competitive by adopting costs saving measures and marketing the products to other territories.
