
17 PROCEDURE FOR APPLICATION AND ACCEPTANCE

17.1 OPENING AND CLOSING OF APPLICATION

Applications will be accepted from 10.00 a.m. on 26 December 2003 and will remain open until 5.00 p.m. on 5 January 2004 or for such other later date or dates as the Directors of the Company and the Underwriter may in their absolute discretion mutually decide. Late applications will not be accepted.

In the event the closing date for the applications is extended, investors will be notified of the change in a widely circulated English and Bahasa Malaysia newspaper in Malaysia.

Copies of the Application Forms together with the Prospectus may be obtained, subject to availability, from the Issuing House, Kenanga, Placement Agents and ADA who is also a KLSE member.

17.2 METHODS OF APPLICATION

Applications for the Public Issue Shares may be made using either of the following ways:

- (i) Application Forms; or
- (ii) Electronic Share Application.

17.3 PRIVATE PLACEMENT AND PUBLIC OFFER PROCEDURES

The public issue will be made by way of private placement and public offer as shown below:-

- (A) Applications for the 4,000,000 Public Issue Shares made available for application by the eligible employees and business associates of the Company must be made on the **Pink** Application Forms provided only and NOT by way of other Application Forms or by way of Electronic Share Application.

Upon the closing of the Application List, in the event any of the 4,000,000 Public Issue Shares are not taken up by the eligible employees and business associates of ASIAEP, such unsubscribed Public Issue Shares will be made available for application by investing public by way of public offer.

- (B) The private placement procedure will be as follows:-
- (i) The potential investors will be pre-identified by the Placement Agents.
 - (ii) Commencing from 26 December 2003 Kenanga and the Placement Agents will send out the Prospectus to this group of pre-identified investors together with the **Blue** Application Forms. Applications for the 47,500,000 Public Issue Shares must be made on the **Blue** Forms provided. Application by way of Electronic Share Application Forms by the pre-identified investors will not be accepted.
 - (iii) The call option holders will be entitled for preference placement shares to be subscribed with the **Blue** Application Forms for the number of shares stated in their respective Options Agreements. The **Blue** Forms will be issued together with the Prospectus.
 - (iv) Upon the closing of the Application List, in the event any Public Issue Shares under Section 17.3(ii)(b) above are not taken up by the holders of the call options, such Public Issue Shares may be transferred from the share option tranche and allocated by way of private placement.
 - (v) Upon the closing of the Application List, in the event of under-subscription for the Public Issue Shares under Section 17.3 (c) above, shares may be transferred from the private placement tranche and allocated by way of public offer.

The public offer procedures will be as follows:-

- (i) Applications for the 2,000,000 Public Issue Shares made available for application by the public must be made on the **White** Application Forms provided or by way of Electronic Share Application.
- (ii) As the issuing house, MIH will, on opening of the Application List, send out the Prospectus to all ADAs which are registered KLSE members together with the **White** Application Forms. Malaysians as well as foreign investors could obtain the **White** Application Forms from the respective ADA.
- (iii) Upon closing of the Application List, in the case of oversubscription of shares in the public offer, balloting will be carried out by MIH.
- (iv) Upon closing of the Application List, in the case of under subscription of shares in the public offer, shares may be transferred from the public offer tranche and allocated by way of placement. Nevertheless, the Placement Agent will inform the KLSE of the reason for transfer and demonstrate that there is a demand for shares under the private placement tranche.

Note:-

- *Only individual applicants, who are Malaysian citizens residing in Malaysia, with CDS Accounts are eligible to apply for the Public Issue Shares using the Electronic Share Application.*

White Application Forms together with copies of this Prospectus may be obtained, subject to availability, from Kenanga, Placement Agents, member companies of the KLSE, members of the Association of Banks in Malaysia, members of the Association of Merchant Banks in Malaysia and MIH.

Applications shall be made in connection with and subject to the terms of this Prospectus and the Memorandum and Articles of Association of ASIAEP.

Applicants may apply for shares under the private placement tranche or the public offer tranche or both. An applicant who has been successfully allocated shares under the public offer may also, at the discretion of the Board, be allocated shares under the private placement and vice versa.

Only 1 Application Form from each applicant will be considered and applications must be for 100 ordinary shares or multiples thereof. **Multiple applications under the public tranche will not be accepted. A person who submit multiple applications in his own name or by using the name of others, with or without their consents, commits an offence under Section 87A of the Securities Industry Act, 1983 ("SIA") and if convicted, may be punished with a minimum fine of RM1,000,000 and to a jail term of up to 10 years under Section 88B of the SIA.**

Persons submitting applications by way of Application Forms or Electronic Share Applications **must have a CDS account.**

The amount payable in full on application is RM0.30 per Public Issue Share. Persons submitting applications by way of Applications Forms may not submit applications by way of Electronic Share Applications and vice versa. A corporation or institution cannot apply for shares by way of Electronic Share Application.

No acknowledgement of the receipt of the Application Form or application monies will be made by the Company.

17.3.1 Terms and Conditions

Applications by way of Application Forms shall be made on, and subject to, the terms and conditions appearing below:

- (a) Applicant who is an individual must be a Malaysian Citizen residing in Malaysia with Malaysian address or Foreign Citizens having a correspondence address in Malaysia. Applicant must have a CDS Account.
- (b) Applicant which are corporations/institutions incorporated in Malaysia must have a CDS account and be subject to the following:
 - (i) If the corporation/institution has a share capital, more than half of the issued share capital (excluding preference share capital) is held by Malaysian citizens; and

The Directors of the Company shall not be responsible for any loss or non-receipt of the said notice nor shall they be accountable for any expenses incurred or to be incurred by the successful applicant for the purpose of complying with this provision.

- (l) The issuing house on the authority of the Directors of the Company reserves the right to reject applications which do not conform to these instructions or which are illegible or which are accompanied by remittances improperly drawn.
- (m) The issuing house on the authority of the Directors of the Company reserves the right not to accept any application or accept any application in part only without assigning any reason therefor. Due consideration will be given to the desirability of allotting or allocating the shares to a reasonable number of applicants with a view to establishing an adequate market for the shares.

(i) Steps for Electronic Share Application through a Participating Financial Institution's ATM

- (a) The applicant must have an account with a Participating Financial Institution and an ATM card issued by that Participating Financial Institution to access the account.
- (b) The applicant must have a CDS account.
- (c) The applicant is to apply for the Public Issue Shares via the ATM of the Participating Financial Institution by choosing the Electronic Share Application option. Mandatory statements required in the application are set out in Section 17.4(ii) below.

(ii) Terms and Conditions

The procedures for Electronic Share Application at ATMs of the Participating Financial Institutions are set out on the ATM screens of the relevant Participating Financial Institutions (the "Steps"). The Steps set out the actions that the applicant must take at the ATM to complete an Electronic Share Application. Please read carefully the terms of this Prospectus, the Steps and the terms and conditions for Electronic Share Application set out below before making an Electronic Share Application. Any reference to "applicant" in the terms and conditions for Electronic Share Application and the Steps shall mean the applicant who applies for shares through an ATM of any of the Participating Financial Institutions. Applications must be made in accordance with the procedures set out on the ATM screens of the relevant Participating Financial Institutions and the instructions, terms and conditions printed in this Prospectus.

In the case of Electronic Share Application, only an applicant who is an individual and who is a Malaysian citizen residing in Malaysia and has a CDS Account can make an Electronic Share Application.

The applicant must have an existing bank account with, and be an ATM cardholder of, one (1) of the Participating Financial Institutions before he can make an Electronic Share Application at an ATM of that Participating Financial Institution. An ATM card issued by one (1) of the Participating Financial Institutions cannot be used to apply for shares at an ATM belonging to other Participating Financial Institutions. Upon the completion of his Electronic Share Application transaction, the applicant will receive a computer-generated transaction slip ("Transaction Record"), confirming the details of his Electronic Share Application. The Transaction Record is only a record of the completed transaction at the ATM and not a record of the receipt of the Electronic Share Application or any data relating to such an Electronic Share Application by the Company or MIH. The Transaction Record is for retention by the applicant and should not be submitted with any Application Form.

Upon the closing of the offer for the application for the Public Issue Shares, on 5 January 2004 at 5.00 p.m. ("Closing date and Time"), the Participating Financial Institution shall submit a magnetic tape containing its respective customers' applications for the Public Issue Shares to MIH as soon as practicable but not later than 12.00 p.m. on the second business day after the closing of the Application List.

An applicant will be allowed to make an Electronic Share Application for shares via an ATM that accepts the ATM cards of the Participating Financial Institution with which he has an account and its branches, subject to the applicant making only one (1) application. An applicant who has a bank account with a Participating Financial Institution and has been issued an ATM card will be allowed to apply for shares via an ATM of that Participating Financial Institution which is situated in another country or place outside of Malaysia, subject to the applicant making only one (1) application.

- I have read the relevant Prospectus and understood and agreed with the terms and conditions of this application;
- This is the only application that I am submitting; and
- I hereby give consent to the Participating Financial Institution and MCD to disclose information pertaining to myself and my account with the Participating Financial Institution and MCD to MIH and other relevant authorities.

The application will not be successfully completed and cannot be recorded as a completed transaction at the ATM unless the applicant completes all the steps required by the Participating Financial Institution. By doing so, the applicant shall be treated as signifying his confirmation of each of the above statements as well as giving consent in accordance with the relevant laws of Malaysia including Section 97 of the Banking and Financial Institutions Act, 1989 and Section 45 of the Securities Industry (Central Depositories) Act, 1991 to the disclosure by the relevant Participating Financial Institution or MCD, as the case may be, of any of the applicant's particulars to MIH, or any relevant regulatory bodies.

- (c) THE APPLICANT CONFIRMS THAT HE IS NOT APPLYING FOR SHARES AS A NOMINEE OF ANY OTHER PERSONS AND THAT ANY ELECTRONIC SHARE APPLICATION THAT HE MAKES IS MADE BY HIM AS BENEFICIAL OWNER. THE APPLICANT SHALL ONLY MAKE ONE (1) ELECTRONIC SHARE APPLICATION AND SHALL NOT MAKE ANY OTHER APPLICATION FOR THE PUBLIC ISSUE SHARES, WHETHER AT THE ATM OF ANY PARTICIPATING FINANCIAL INSTITUTION OR ON THE PRESCRIBED APPLICATION FORMS.

If the applicant's Electronic Share Application is successful, his confirmation (by his action of pressing the designated key or button on the ATM) of the number of shares applied for shall signify, and shall be treated as, his acceptance of the number of shares that may be allotted or allocated to him and to be bound by the Memorandum and Articles of Association of the Company.

The issuing house on the authority of the Directors of the Company reserves the right not to accept any application which does not strictly comply with the instructions or to accept any application in part only without assigning any reason therefor.

The submission of an Application Form does not necessarily mean that the application will be successful.

ALL APPLICATIONS MUST BE FOR 100 ORDINARY SHARES OR MULTIPLES THEREOF.

In the event of an over-subscription, acceptance of applications shall be subject to ballot to be conducted in the manner approved by the Board. Due consideration will be given to the desirability of distributing the Public Issue Shares, to a reasonable number of applicants with a view to broadening the shareholding base and establishing an adequate market in the shares of the Company. Pursuant to the Listing Requirements of the KLSE, at least 25% of the enlarged issued and paid-up share capital of the Company must be held by a minimum number of 200 public shareholders. In the event that the above requirement is not met pursuant to the Issues, the Company may not be allowed to proceed with the Listing. In the event thereof, monies paid in respect of all applications will be returned without interest if the said permission for listing and quotation is not granted.
