#### 1. Basis of Preparation

The interim financial report is unaudited and is prepared in accordance with the requirements of the Financial Reporting Standard (õFRSö) 134: Interim Financial Reporting and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") for the ACE Market. The interim financial report do not include all of the information required for full annual financial statements, and should be read in conjunction with the audited financial statements of the Company for the financial year ended 30 June 2017.

The accounting policies and methods of computation adopted by the Group in this interim financial report are consistent with those adopted in the most recent audited annual financial statements for the financial year ended 30 June 2017.

#### 2. Audit report

The audit report of the Company preceding annual financial statements was qualified. The basic for qualified opinion is that the Group and the Company incurred net losses of RM8,587,693 and RM7,149,919 respectively for the financial period ended 30 June 2017 and as of 6 March 2018, the Group current and total liabilities exceeded its current and total assets by RM2,463,543 and the Company current and total liabilities exceeded its current and total assets by RM396,344 and RM396,343 respectively. These indicate the existence of material uncertainties which may cast significant doubt on the ability of the Group and of the Company to continue as going concerns and therefore they may be unable to realise their assets and discharge their liabilities in the normal course of business.

On 30 November 2017, the Company announced that it became an Affected Listed Company pursuant to Guidance Note 3 of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad and the Company is in the process of finalising a regularisation plan. The ability of the Group and of the Company to continue as going concerns are highly dependent upon the successful implementation of the regularisation plan and the ability of the Group and of the Company to attain profitable operations to generate sufficient cash flows to fulfil their obligations as and when they fall due.

#### 3. Seasonal or Cyclical Factors

The business of the Company is not affected by any significant seasonal or cyclical factors.

#### 4. Unusual items

There were no unusual items during this quarter affecting assets, liabilities, equity, net income or cash flow.
