A. NOTES TO THE UNAUDITED INTERIM FINANCIAL STATEMENTS FOR THE PERIOD ENDED 31 MARCH 2008

A1. Basis of Preparation

The interim financial statements are unaudited and have been prepared in compliance with Financial Reporting Standards ("FRS") 134: Interim Financial Reporting issued by the Malaysian Accounting Standards Board (MASB) and Rule 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad for the MESDAQ Market.

B. ADDITIONAL INFORMATION REQUIRED BY THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD

B1. Review of Performance

During the quarter under review, the Group's revenue of 7.893 million was higher than the preceding year corresponding quarter's revenue of RM7.433 million. However, profit before tax ("PBT") for the quarter declined to RM0.307 million against the preceding year corresponding quarter's PBT of RM1.476 million. The decline was mainly attributable to increased costs in relation to higher headcount and increased international business development activities undertaken.

B2. Material Changes in the Quarterly Results Compared to the Immediate Preceding Quarter

The current quarter's PBT of RM0.307 million was lower compared to the immediate preceding quarter's RM1.534 million due to lower revenue contributions from the retail, hospitality and consulting services. In addition, higher staff costs compounded towards the performance of the Group during the period under review.

B3. Prospects

The Group continues to pursue international business expansion opportunities through various regional initiatives in progress. Concurrently, the Group will continue to explore and pursue potential mergers and acquisitions with synergistic businesses locally and abroad.

On that note, the Board remains optimistic of a satisfactory performance for the coming quarters of the current financial year.

No financial forecast was announced or made hence there was no comparison between actual results and forecast.

The Group's effective tax rate was lower than the statutory tax rate of 26% due to the tax exemptions on profits generated by two (2) of the Group's subsidiaries with Multimedia Super Corridor ("MSC") status with pioneer status.
