B1. Review of Performance

For the financial period under review, the Group continued its strategy to develop sustainable relationships with our customers through the introduction of managed services and solution subscription models. This has resulted in lower one-time POS related sales revenue in exchange for a higher recurring revenue contribution.

The Group has secured long term subscription contracts and Call Order Delivery Services ("CODS") solutions contracts from customers which contributed total sold backlog of approximately RM57.63 million over the next 5 years, compared to RM53.85 million as reported in the previous quarter.

The Group's revenue for the current financial quarter under review was higher compared to the preceding year corresponding quarter's revenue due to higher revenue from its managed services and subscription services

The Group recorded a profit before tax ("PBT") of RM0.18 million compared to loss before tax of RM1.28 million for the preceding year's corresponding quarter primarily due to the exceptional gain from the divestment of its network security solutions business unit.
