B1. Review of Performance

The Group's revenue for the current financial quarter was lower compared to the preceding year corresponding quarter's revenue due to the divestment of the network security solution business unit which contributed RM4.4million revenue in the preceding year corresponding quarter,

Arising from the divestment of the network security solution business unit, the group experienced lower operating cost. In addition, there were significant savings from stringent cost control measures. The operating loss for the current financial quarter under review narrowed to RM1.2million from the operating loss of RM1.7million in the preceding year's corresponding quarter.

The Group recorded a higher investment in research & development that resulted in higher amortisation cost reported for the current financial quarter under review.

B2. Material Changes in the Quarterly Results Compared to the Immediate Preceding Quarter

The Group's revenue for the current financial quarter under review was lower compared to the immediate preceding quarter due to a sudden weaker market condition.

The Group recorded a loss before tax of RM3.3 million compared to profit before tax of RM0.22 million.

B3. Prospects

The Group expects the weak market condition to persist in the short to medium term. The weakening of Ringgit against major currencies will have an adverse impact on the operations.

The Group currently records a relatively healthy sales order book amounting RM55 million including recurring revenue up to 2018. The Group has progressively commercialised its REV offering and there are immediate opportunities in SEA and China.

No financial forecast was announced or made hence there was no comparison between actual results and forecast.
