#### A1. Basis of Preparation

Pursuant to the announcements made by Sersol on 25 and 30 November 2011, 31 January 2012 and 27 February 2012, the Company's 50% subsidiary in China sustained a loss of RM0.927 million during the period from 1 January 2009 to 30 September 2011 due to cash embezzlement committed by the subsidiary's former employee. The loss attributable to the shareholders of Sersol, after taking into consideration minority interests, is RM0.463 million. For the year ended 31 December 2011 and the corresponding preceding year, the losses sustained by the Group as a result of the embezzlement is RM0.160 million and RM0.111 million respectively. In addition, an impairment loss of RM0.522 million is provided on the property, plant & equipment of the above mentioned subsidiary.

Save for the above mentioned cash embezzlement and impairment loss in respect of property, plant & equipment, during the quarter under review and financial year-to-date, there were no items affecting assets, liabilities, equity, net income or cash flows of the Group that are unusual because of their nature, size or incidence.

#### A4. Material Change in Estimates

There were no changes in estimates amount reported as at to date that would have a material effect on the results for the current quarter under review and financial year-to-date.

# B. ADDITIONAL INFORMATION REQUIRED BY THE LISTING REQUIREMENTS OF THE BURSA MALAYSIA SECURITIES BERHAD FOR THE ACE MARKET

### B1. Review of Group's Results for the Current Quarter and Financial Year-to-date Ended 31 December 2011

For the current quarter under review, our Group's revenue is RM5.625 million, showing a decrease of revenue by RM1.322 million, representing a decrease of approximately 19.03% as compared to the restated corresponding financial quarter ended 31 December 2010. Our Group recorded a loss after taxation of RM1.375 million for the current quarter ended 31 December 2011 as compared to the loss after taxation of RM1.138 million for the restated corresponding quarter ended 31 December 2010. The increase in losses is mainly due to the impairment of RM0.522 million on property, plant & equipment sustained by our 50% owned subsidiary in China which was partially set off by lower operating expenses for the Group. Our Group's largest revenue contributor for the current quarter is the Coating Manufacturing Division (RM4.333 million) followed by the Metal Trading Division (RM1.155 million).

For the current financial year, our Group's revenue is RM30.116 million, showing an increase of revenue of RM5.095 million, representing an increase of approximately 20.36% as compared to the restated preceding year ended 31 December 2010. Our Group recorded a loss after taxation of RM2.217 million for the current year as compared to the loss after taxation of RM2.513 million for the restated corresponding financial year ended 31 December 2010. The losses arose mainly due to revenue of our foreign subsidiaries being insufficient to meet their operating expenses as well as the above mentioned impairment of property, plant & equipment on our 50% owned subsidiary in China. Our Group's largest revenue contributor is the Coating Manufacturing Division (RM21.859 million) followed by the Metal Trading Division (RM7.993 million). In geographic terms, Malaysia remains our largest revenue contributor for the current year at RM21.847 million. Whereas the loss sustained by Malaysia is not significant, our Group's losses is mainly caused by our foreign subsidiaries which performed below expectations.

Included in the above losses is the loss arising from the cash embezzlement as highlighted in Note A3 which amounted to RM0.160 million for the current financial year and RM0.111 million for the restated preceding financial year ended 31 December 2010.

# B2. Variation of Results For the Current Quarter Ended 31 December 2011 against Immediate Preceding Quarter

During the current quarter ended 31 December 2011, our Group's revenue is RM5.625 million, showing a decrease of revenue of RM2.559 million, representing a decrease of approximately 31.27% as compared to the immediate restated preceding quarter ended 30 September 2011. Our Group recorded a loss after taxation of RM1.375 million in the current quarter ended 31 December 2011, as compared to a loss after taxation of RM0.412 million in the restated previous quarter ended 30 September 2011. The increase in losses is due to the decrease in revenue from our subsidiary companies as well as the above mentioned impairment of property, plant & equipment on our 50% owned subsidiary in China.

# B3. Prospects for 2012

Our board of Directors expects the business environment for the forthcoming year to remain challenging. We will continue to be prudent in our cost management and will be evaluating our strategic directions in respect of our non-profitable subsidiaries.
