A. Explanatory Notes Pursuant to Malaysian Financial Reporting Standard 134 ("MFRS 134")

A1. Basis of Preparation

The unaudited interim financial statements, for the period ended 30 September 2015, have been prepared in accordance with MFRS 134, *Interim Financial Reporting* issued by the Malaysian Accounting Standard Board ("MASB") and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities").

The unaudited interim financial statements should be read in conjunction with the annual audited financial statements of the Group for the financial year ended 31 December 2014. The explanatory noted attached to the interim financial statements provide an explanation of events and transaction that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 December 2014.

Since the previous annual audited financial statements as at 31 December 2014 were issued, the Group has adopted the Malaysia Financial Reporting Standards ("MFRS") framework issued by MASB with effect from 1 January 2012. This MFRS framework was introduced by the MASB in order to fully converged Malaysia's existing Financial Reporting Standards ("FRS") framework with the International Financial Reporting Standards ("IFRS") framework issued by the International Accounting Standards Board.

At the date of issuance of this unaudited interim financial statements, the MFRSs, amendments to MFRSs and IC Interpretation have been issued by MASB but not yet effective are as listed below:

B1. Review of Group's Performance

Current Year- to date vs. Previous Year-to date

For the 9 months ended 30 September 2015, the Group registered a turnover of RM18.9 million, 19% or RM2.99 million higher compared to the same corresponding period last year. The increase in revenue is mainly contributed from Application Solution (AS) segment.

The profit before tax (PBT) for the period under review stood at RM7.47 million, lower by RM684K (or 8%) as compared to the same period last year. This is mainly due to the previous year's other income includes the one time gain on disposal of office premise at Jaya One.

The profit after tax (PAT) recorded at RM5.78 million, a decrease of RM854K or 13% compared to corresponding period last year.

The Group's revenue for current quarter record at RM6.29 million, increase by BM468K or 7% compared to immediate preceding quarter. This was attributed by higher sales recorded for Application Service Provider and Application Solution segment.

PBT in current quarter stood at RM2.302 million, slight decrease of 1% or RM23K compared to immediate preceding quarter. This was mainly due to higher cost of sales and operating expenditure.

PAT recorded at RM1.92 million, increase of 8% or RM176K as compared to immediate preceding quarter.

B3. Prospects for 2015

Looking ahead, the Group will continue to focus on enhancement, development and implementation of its products. In spite of uncertainties in world economic climate, the Board remains optimistic of achieving a satisfactory performance for the financial year ending 31 December 2015.

B4. Variance of Profit Forecast and Shortfall in Profit Guarantee

The Group has not issued any profit forecast nor profit guarantee for the current financial quarter under review and the financial period to-date.
