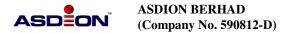

NOTES TO INTERIM FINANCIAL REPORT

PART A – Explanatory Notes Pursuant to Financial Reporting Standard 134 ("FRS 134")

1. Basis of Preparation

The interim financial report is unaudited and is prepared in accordance with FRS 134 "Interim Financial Reporting" issued by the Malaysia Accounting Standard Board and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") for the ACE Market and should be read in conjunction with the audited consolidated financial statements of Asdion for the financial year ended 31 December 2008. 15. Review of Performance for the Current Quarter and Year-to-date

For the fourth quarter ended 31 December 2009, the Group continue to record higher revenue of approximately RM1.92 million, an increase of 98.74% as compared to the revenue achieved in the 2008 fourth quarter of approximately RM0.96 million. The increase of the revenue mainly attribute to the sales generated in the Customer relationship management ("CRM") data services segment.

The Group recorded a lower loss before tax ("LBT") of approximately RM1.48 million for the current quarter as compared to the immediate preceding quarter of a LBT of RM2.07 million. The improved performance is in-line with the Groups' ongoing efforts to expand and strengthen its core business.

For the FYE 2009, the Group recorded revenue of approximately RM6.44 million with a LBT of approximately RM3.56 million as compared to the revenue of approximately RM5.77 million and a PBT of RM6.26 million recorded in the preceding corresponding year. The approximately 11.53% increase of revenue was attributed to the increase in sales of CRM data services segment. The loss was largely due to the share of loss of associate.

16. Comparison between the Current Quarter and the Immediate Preceding Quarter

For the current quarter ended 31 December 2009, the Group continues to achieve higher revenue of approximately RM1.92 million, representing an increase of 21.81% compared to revenue of approximately RM1.57 million recorded in the immediate preceding quarter ended 30 September 2009. The increase in revenue was mainly attributed to the strengthening of the sales on data services segment and Alliance Marketing segment.

The Group recorded a LBT of approximately RM1.43 million as compared to a LBT of approximately RM0.74 million registered in the immediate preceding quarter. The increase of the loss was mainly due to the share of loss of associate.

17. Prospects for the Current Financial Year

In view of the competitive market conditions in the ICT industry, the Directors of AB anticipate that the business outlook of the Group for the FYE 2010 to be challenging. The Group will continue to focus on its core business activities and deploy appropriate sales and marketing strategies to further penetrate the Group's market coverage.

18. Profit Forecast and Profit Guarantee

The Group did not issue any profit forecast or profit guarantee during the current financial period to-date.
