A EXPLANATORY NOTES PURSUANT TO MFRS 134

B1 Review of performance

The Group recorded higher revenue of RM57.57 million for the current quarter as compared to RM24.18 million in the preceding period corresponding quarter. The increase in the Group revenue was mainly due to higher trading activities in palm oil products. The Group recorded a higher loss before tax of RM0.11 million for the current quarter as compared to profit before tax of RM0.11 million in the preceding period corresponding quarter. The loss before tax for the current quarter was higher as a result of lower selling prices of palm kernel oil due to suppressed global prices as compared to previous year. The operations of the palm kernel crushing activities continued to incur losses due to its low level of crushing activities.

B2 Variation of results against preceding quarter

The Group recorded higher revenue of RM57.57 million for the current quarter as compared to RM48.67 million in the preceding quarter. The increase in the Group revenue was due to higher trading activities in palm oil products.

The Group recorded a lower loss before tax of RM0.11 million for the current quarter as compared to the preceding quarter loss before tax of RM0.74 million. The current quarter losses were lower in tandem with higher revenue and better margin from certain palm oil products in the current quarter under review.

B3 Prospects

The prospect of the Group for the remaining financial year remains challenging. As the Group continues to concentrate on enhancing its palm kernel crushing activities so as to improve its revenue, it is also facing low supply of raw materials and lack of working capital.

Notwithstanding, the Group has taken steps to explore and introduce new products, and to trade in other palm oil related products.

B4 Profit forecast / Profit guarantee

The Group did not issue any profit forecast or profit guarantee in any public documents.

B5 Taxation

There is no provision for taxation for the financial year as the companies in the Group have no chargeable income.
