# B EXPLANATORY NOTES PURSUANT TO APPENDIX 9B OF THE LISTING REQUIREMENTS OF BURSA MALAYSIA SECURITIES BERHAD FOR THE ACE MARKET

#### B1 Review of performance

The Group recorded a turnover of approximately RM0.86 million for the current financial quarter, this represents a reduction of approximately 42% as compared to the same corresponding financial quarter in 2008 ("Q2 2008). As a result of lower turnover from its operations in Malaysia and higher operating costs incurred in current financial quarter, the Group recorded a loss before taxation of RM1.04 million for the current quarter as compared to a loss before taxation of RM0.21 million recorded in Q2 2008.

For the 6 months ended 30 June 2009, the Group recorded a turnover and loss before taxation of approximately RM1.95 million and RM2.02 million respectively.

## B2 Variation of results against preceding quarter

The Group recorded a turnover of approximately RM0.86 million for the current financial quarter, this represents a reduction of approximately 22% as compared to the preceding financial quarter ("Q1 2009). As a result of lower turnover from its operations in Malaysia, the Group recorded a loss before taxation of RM1.04 million for the current quarter as compared to a loss before taxation of RM0.98 million recorded in Q1 2009.

#### **B3** Prospects

Based on the performance to date and the current global financial turmoil, the Board expects that Year 2009 will be a challenging year for the Group.

## B4 Profit forecast and profit guarantee

The Group did not announce any profit forecast nor profit guarantee during the financial quarter.

#### **B5** Taxation

The Company and its subsidiary have been awarded Multimedia Super Corridor status. Accordingly, there is no tax charge on the business income for the financial quarter under review as the Company and its subsidiary have been granted pioneer status under the Promotion of Investments (Amendment) Act, 1997.

No provision for income tax has been made for foreign subsidiary as the foreign subsidiary incurred operating loss.

The Company is claiming for an outstanding amount of RM1,751,617.27 and interest charges at the rate of 8% per annum on the aforesaid amount from the date of filing of the Writ of Summons until the payment date. The claims represent outstanding payments due from Metronic for the development and provision of the Company's software pursuant to the Software Development Agreement dated 9 May 2005 between the Company and Metronic.

The legal proceeding is still on-going.
