For the current financial quarter ended 30 June 2019, the Group achieved unaudited revenue of RM1.44million which is lower than the revenue of RM1.60million recorded in the previous year corresponding quarter. The decrease in revenue is mainly due to the lower income generated from the property management services.

The profit after tax of the Group for the current financial quarter was approximately RM0.05million which was lower than RM0.13million recorded in the previous year corresponding quarter. The decrease in profit after tax was mainly attributed to lower income generated from the property management services.

The profit after tax of the Group for the current financial quarter RM0.05million was lower than that profit after tax of the immediate preceding quarter RM0.11million principally attributed to lower income generated from the property management services during the current financial quarter.
