A. EXPLANATORY NOTES PURSUANT TO MFRS 134: INTERIM FINANCIAL REPORTING

B. ADDITIONAL INFORMATION PURSUANT TO BURSA SECURITIES LISTING REQUIREMENTS

B1. Review of the Group's results for the current financial quarter ended 30 September 2019

For the current financial quarter ended 30 September 2019, the Group achieved unaudited revenue of RM1.53million which is slightly highest than the revenue of RM1.47million recorded in the previous year corresponding quarter. The increase in revenue is mainly due to the highest income generated from the property management services.

The profit after tax of the Group for the current financial quarter was approximately RM0.36million which was slightly highest than RM0.10million recorded in the previous year corresponding quarter. The increase in profit after tax was mainly attributed to highest income generated from the property management services.

B2. Material changes in profit after tax for the current financial quarter compared to the immediate preceding quarter

The profit after tax of the Group for the current financial quarter RM0.36million was highest than that profit after tax of the immediate preceding quarter RM0.05million principally attributed to highest income generated from the property management services during the current financial quarter.

B3. Current year prospect

Barring unforeseen circumstances, the Board of Directors anticipates that the financial performance of the Group will remain satisfactory for the financial year ending 31 December 2019.
