A. EXPLANATORY NOTES PURSUANT TO MFRS 134: INTERIM FINANCIAL REPORTING

A1. Basis of preparation

The interim financial report is unaudited and has been prepared in accordance with MFRS 134: Interim Financial Reporting and Paragraph 9.22 of Bursa Malaysia Securities Berhad (“Bursa Securities”) Listing Requirements. This interim financial report does not include all the information required for a full set of annual audited financial statements, and should be read in conjunction with the Annual Audited Financial Statements of the Group for the financial period ended 30 June 2020, which have been prepared in accordance with Malaysian Financial Reporting Standards (“MFRSs”), International Financial Reporting Standards.

The Group has adopted all applicable accounting standards, amendments and interpretations that have been issued by the Malaysian Accounting Standards Board (“MASB”) except for those which are not yet effective. B1. Review of the Group's results for the current financial quarter ended 31 March 2021

For the current financial quarter ended 31 March 2021, the Group achieved unaudited revenue of RM4.25million which is higher than the revenue of RM0.76million recorded in the previous period corresponding quarter. The increase in revenue is mainly due to the higher income generated from trading in building and construction materials.

B2. Material changes in profit after tax for the current financial quarter compared to the immediate preceding quarter

The profit after tax of the Group for the current financial quarter was approximately RM0.65million which is higher than profit after tax RM0.042million recorded in the previous period corresponding quarter. The increase in profit is mainly due to the higher revenue generated from trading in building and construction materials.

B3. Current year prospect

Barring unforeseen circumstances, the Board of Directors anticipates that the financial performance of the Group will remain challenging for the financial year ending 30 June 2021.

B4. Profit forecast / Profit guarantee

There was no profit forecast or profit guarantee in respect of the current financial year.
