The decrease in revenue is mainly due to the lower income generated from trading in building, steel and construction materials.

B2. Material changes in profit after tax for the current financial quarter compared to the immediate preceding quarter

The profit after tax of the Group for the current financial quarter was approximately RM0.25million which is lower than profit after tax RM0.65million recorded in the previous period corresponding quarter. The decrease in profit is mainly due to the lower profit margin generated from trading in building, steel and construction materials.

B3. Current year prospect

Barring unforeseen circumstances, the Board of Directors anticipates that the financial performance of the Group will remain challenging for the financial year ending 30 June 2022.

B4. Profit forecast / Profit guarantee
